September 24, 1985 - MIRU. Killed well with 140 bbls water. Circulated down tbg and out annulus. Well head not serviceable. Pumped cement slurry down 6 5/8 annulus and out 2 3/8 tbg. Plugged and abandoned Sept. 24, 1985 with 320 sks 50/50 posmix, 2% gel, class 'c' cement by Halliburton. Used 50% excess of capacity. Erect dry-hole marker & cleaned location.
