Well was cleaned out to 2080 Ft. with rotary equipment. 1815 Ft. of 5 $\frac{1}{2}$ - 13 Lb. - 8 Rd. Th. used casing run as liner. Cemented back to surface in annulus between 5 $\frac{1}{2}$ " casing and original 8-1/4" casing to stop leaks (Halliburton job). Bradenhead installed at surface. Job satisfactory. 2013 Feet 2" upset tubing rerun as water bleeder
