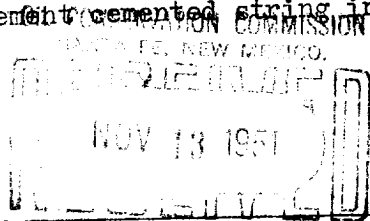

All of pipe with exception of some 10" production string pulled from this old well and plugged in 4/5/32. This plugged approximately 950' from surface by 30' wooden plug and small amount of concrete. Plug removed and bottom hole 2506'. 5½" size of pipe was set at 1987'. 600 sacks of cement cemented string in place. Done by Halliburton of Texhoma.
