- 3) Pumped 11 cu.ft. Class H cement plug in 13 ppg slurry from 477-457'.
- 4) Pulled up to 410'. Pumped 25 cu.ft. Class H cement in 13 ppg slurry from 410-360' across 7" casing @ 380'.
- 5) POH and laid 3 sx plug @ surface.
- 6) Installed required dry hole marker - 11/12/82.
