- 8/15/77 Move in Gunn-Campbell Well Servicing. Set Baker BP at 785 ft. Run dump bailer with 1 sack cement on top of BP, PBD 981 ft. Unload and rack 2-3/8" tubing.
- 8/16/77 Run 32 jts. 2-3/8" EUE tubing with seating nipple on bottom to 970 ft. Swabbed well as follows:
11:00 A.M. Swabbing from SN fluid 100'-125' off bottom, gas ahead of swab.
11:30 A.M. Swabbing from SN fluid 75' off bottom gas ahead of swab.
Shut down one hr. for fluid buildup.
12:30 P.M. Swab from SN 80' fluid in hole, gas ahead of swab.
3:30 P.M. Swab from SN 30' fluid in hole, gas ahead of swab.
4:30 P.M. Swab from SN 30' fluid in hole, gas ahead of swab.
Shut down, left well open.
- 8/17/77 400 ft. of fluid in well.
8:00 A.M. Swabbing.
9:00 A.M. Swab from SN fluid 150' off bottom, gas ahead of swab.
10:00 A.M. Swab from SN fluid 50' off bottom, gas ahead of swab.
11:00 A.M. Swab from SN fluid 40' off bottom, gas ahead of swab.
12:00 A.M. Swab from SN fluid 40' off bottom, gas ahead of swab.
By 2:30 P.M. fluid recovery down to 10 ft., still getting gas ahead of each swab run. Shut down at 3:30 P. M., heavy rains, left well open.
- 8/18/77 400 ft. of fluid in well. Start swabbing, gas ahead of swab. By 11:00 A.M. fluid was down to 30 ft., shut down for 45 minutes., recovered 40' fluid, gas ahead of swab. Shut down 1-1/2 hrs., recovered 20' fluid, gas ahead of swab. Swabbed dry at 2:15 P.M., Wait 45 minutes, recovered 50' fluid, shut down. Left well open.
- 8/19/77 600 ft. of fluid in well this A.M., gas ahead of swab. Significant increase in gas.
9:00 A.M. Swabbing from SN fluid 200' off btm. gas ahead of swab.
10:00 A.M. Swabbing from SN fluid 20' off btm. gas ahead of swab.
Shut down for one hour.

7 11 1977

11:00 A.M. 150 ft. fillup, increase in gas.
12:00 fluid down to 30 ft. shut down one hour.
1:00 P.M. 115 ft. fillup, gas ahead of swab.
2:00 P.M. shut down one hour.
3:00 P.M. 100 ft. fillup, gas ahead of swab, swabbed down by 4:30 P.M.
shut down, left well open.

8/20/77 555 ft. fluid this A.M. gas approx. the same as 8/19 swabbed down by
11:30 A.M., shut down, shut well in.

8/21/77 Sunday - shut down.

8/22/77 Had slight blow when opened - ⁺ 5 psi. 650 ft. of fluid. Ran swab, gas
appears to be about the same. Pulled tubing prep. to move to Lee
Daniels.
