This well was spudded 12/15/77. Set 14 joints (588.42') of 8-5/8" 24#, K55,8R, ST&C casing at 605.37' and cemented with 375 sacks of Class C w/2% CaCl₂. Cement circulated. Bumped plug with 900# - OK. WOC 7-1/2 hours. Tested casing, BOP and manifold to 800# - OK.

New Mexico Oil Conservation Commission notified but did not witness.
