Propose to plug well as follows:

Trip in hole with open ended drill pipe to TD and spot a 25 sx plug. Pull to 9850' and spot 100' (50 sx) plug of class H neat from 9850'-9750' at the top of Mississippian. Pull up to 6850' and spot a 100' (70 sx) class H neat plug from 6850'-6750' at the top of Penn. Pull up to 4360' and spot a 100' (75 sx) class H neat plug from 3550'-3450' across the intermediate csg shoe at 3550'. Spot a 10 sx surface plug and erect PXA Marker.
