60' of 8-7/8 surface casing was set and cemented. 723' of 6-5/8" 14# water control casing was set and later removed prior to setting 50' cement plug at 672' to 722' to separate surface shale water from Fort Hayes Lime and Dakota SS.

Total depth of well 1048'. 3" hole was drilled to 723'; then hole reduced to 6" to total depth.
