MIRUSU, kill well with fresh water, NUBOP, release packer, lay down 2 7/8" production tubing and packer, SDON.

10/22/99

Kill well with fresh water, run 2 3/8" workstring to 2,480 feet. spot 70 sacks of Class C cement from 2480' - 1960', pull workstring uphole, WOC 4 hours, run workstring, tag cement at 1960', pressure test casing to 500 psi, displace casing with corrosion inhibited fluid, spot 10 sacks of cement from 1960' - 1864', pull workstring to 30 feet and spot 5 sacks of cement from 30' - 3', NDBOP, cut off wellhead, install PXA marker, RDMOSU, cut off well anchors and clean location.
