## Hello,

I am not going to file a formal response to Solaris' motion because NGL agrees to the continuance, to July 25. I would note, however, that when Solaris' counsel approached me about a continuance, NGL agreed to continue this case, if Solaris would, in turn, agree to continue the cases the motion refers to that are going to be set for the July 11 hearing. Solaris did not agree with this approach, but instead filed the motion to continue. I would also note that NGL is within its rights to file this case as an application for hearing, rather than for administrative approval first, and was not required to provide Solaris with notice of so doing. Further, OCD has had a copy of NGL's application, including the C-108, since it was filed, so the statement in the motion that "OCD will not become of aware of the technical basis for the application until the hearing" is inaccurate.
