1 HEARING EXAMINER LOWE: Good morning. This is

- OCD Hearing Docket Number 42-19. Today is November 14,
- 3 2019. We are on the record; we will conduct today's
- 4 hearings.
- 5 My name is Leonard Lowe and I will be your
- 6 Hearing Examiner today. Today with me we have our attorney
- 7 Eric Ames, Phillip Goetze helping us out, and Kathleen
- 8 Murphy and an elite team on that side over there.
- 9 This morning I'm going to have Kathleen call out
- 10 the dismissals and continuances that we were made aware of
- 11 prior to today's docket. Ms. Murphy.
- 12 EXAMINER MURPHY: The following cases are
- 13 dismissed: Case 20828, Ridge Runner; Case 20815, Novo Oil &
- 14 Gas; 20816, Novo Oil & Gas; 20890, Devon Energy; 20900,
- 15 Black River Water Management; 20901 Texland Petroleum; 20849
- 16 Kaiser-Francis; 20850, Kaiser-Francis; 20851,
- 17 Kaiser-Francis; 20852, Kaiser-Francis; 20853,
- 18 Kaiser-Francis; 20912, BTA Oil, and 20913.
- 19 The following cases have been continued. I will
- 20 read the case number, and the date that they are continued
- 21 to tentatively.
- The following cases are continued to December 12,
- 23 2019, and those are cases 20856, COG, and 20857, also COG.
- The following case is continued to January 23,
- 25 2020, and that is Case 20827 Advanced Energy Partner.

1 The following cases are continued to February

- 2 2 -- February 20, 2020. These are all Marathon Oil Permian
- 3 LLC cases, 20840, 20841, 20842, 20843, 20844, 20845, 20846,
- 4 20847, 20848.
- 5 Also to February 20, 2020, 20830 Centennial
- 6 Resources; 20831, Centennial Resources; 20833, Titus Oil &
- 7 Gas; 20834, Titus Oil & Gas; 20835, Titus Oil & Gas; 20817
- 8 Novo Oil & Gas Northern Delaware; 20861, VF Petroleum; 20862
- 9 VF Petroleum; 20873, Novo Oil & Gas Northern Delaware;
- 10 20874, Novo Oil & Gas Northern Delaware; 20876, COG
- 11 Operating; 20877, COG Operating; 20878, Titus Oil & Gas;
- 12 20879, titus Oil & Gas; 20880, Titus Oil & Gas and 20881
- 13 Titus Oil & Gas.
- And also continued to February 20, 2020; 20882,
- 15 Titus Oil & Gas; 20897, Titus Oil & Gas; 20898, Titus Oil &
- 16 Gas; 20899, Titus Oil & Gas.
- 17 And then the rest of these are Matador
- 18 Production: 20904, 20905, 20906, 20907, 20908, 20909, 20910
- 19 and 20911.
- 20 Those are the continuances and dismissals that we
- 21 have at this time. Are there any additions or subtractions
- 22 to that?
- 23 (No audible response.)
- 24 HEARING EXAMINER LOWE: Thank you, Kathleen.
- 25 Thank you. All righty then. Can I just -- items.

1 MR. AMES: So, Counsel, we have taken the liberty

- 2 of ordering the remaining 42 cases on the docket, and we
- B have a spreadsheet that we would like to distribute which
- 4 shows the order we will take the cases. We will show how we
- 5 are going to do.
- I only have 12 copies, so if I can hit primary
- 7 counsel, there are a few I know who has cases on the docket.
- 8 EXAMINER MURPHY: Eric, there are copies in the
- 9 back.
- 10 MR. AMES: I grabbed them. Who else needs a
- 11 copy? I have a few more. Other counsel? Next time we will
- 12 make more copies. Kathleen suggested that earlier. Sorry
- 13 Kathleen.
- 14 Anybody else? There's a couple of extra copies.
- 15 Who else needs a copy? Well, there is two more here if you
- 16 folks want them. I guess we do have enough. So you will
- 17 notice that the cases are numbered 1 to 42. All the
- 18 hearings are at the end from 38 to 42.
- 19 We will have a discussion after the conclusion of
- 20 the cases 1 through 37 about the order in which we will take
- 21 the hearings. My understanding is that some counsel have
- 22 issues with witnesses tomorrow, and so we will need to have
- 23 a discussion among the counsel for the cases set for hearing
- 24 on how best to take them.
- 25 In terms of the remaining cases, you will notice

on the right side it says, in the last column, affidavit or

- 2 hearing. Cases 1 through 25 have no other entries of
- 3 appearance or notices of intervention, and those will be
- 4 taken by affidavit in the order given.
- 5 Cases 26 through 37 say TBD, that is because
- 6 there are entries of appearance in those cases and in at
- 7 least a couple of them there are prehearing statements
- 8 filed. I have talked to counsel for both the applicants and
- 9 for the parties, and it's my understanding those cases can
- 10 also proceed by affidavit, and so we will take them in the
- 11 order given there.
- 12 What we would like to do is, in taking the cases
- 13 by affidavit, is follow the process which we initiated in
- 14 the last round of hearings, which is to have counsel make
- 15 their appearances, have counsel for the applicant introduce
- 16 themselves, the name of their applicant, maybe one or two
- 17 sentences about the case, and then a very brief description
- 18 of the exhibits, ask us to accept the exhibits into the
- 19 record, and take the case under consideration, and then we
- 20 will move on.
- I am hoping that if we keep to a streamlined
- 22 approach, we can move through these 37 cases quickly. If
- 23 any issues arise during the presentation of a case where
- 24 counsel has an issue, just raise it and we'll address it in
- 25 that content.

1 So unless there is anything general that anyone

- 2 wants to raise regarding this process, we'll jump right in
- 3 and start with Mr. Feldewert.
- 4 MR. RANKIN: Mr. Examiner, one point of
- 5 clarification, a couple of these are listed as affidavit
- 6 cases when in fact we have live witnesses. I just want to
- 7 make that point so you are not surprised.
- 8 MR. AMES: You intend to present live witnesses?
- 9 MR. RANKIN: Yes.
- MR. AMES: Which cases are those?
- 11 MR. RANKIN: Looking at your list, it's case
- 12 numbers 19 through 22 that, in fact, will be presented by
- 13 live witness.
- MR. AMES: Okay. Anyone else?
- 15 MR. RANKIN: And then, Mr. Ames, case number 26
- 16 on your list, it's an affidavit case. It was with the
- 17 consent of the State Land Office.
- 18 MS. ANTILLON: The State Land Office concurs.
- 19 MR. AMES: So Mr. Rankin, we are going to move 19
- 20 through 22 to the very end of the cases by affidavit, and
- 21 we'll consider the order of presentation of those hearings
- 22 when we get there.
- 23 All right.
- 24 (Cases by affidavit presented and taken under
- 25 advisement.)

1 HEARING EXAMINER LOWE: We are going to take a

- 2 ten-minute break while we discuss our next case, and we'll
- 3 convene here in about ten minutes.
- 4 (Recess taken.)
- 5 HEARING EXAMINER LOWE: We are back on the
- 6 record.
- 7 MR. AMES: To all the counsel this morning, we
- 8 were able to go through -- process 30 cases in three hours.
- 9 That seems pretty good. There is two more cases pending by
- 10 affidavit, and Mr. Bruce has agreed that they will be heard
- 11 tomorrow morning at 8:15.
- We have ten cases for hearing. There has been a
- 13 discussion and agreement amongst counsel to the order of
- 14 presentation.
- 15 We are going to begin with NGL 20896 slash 16507.
- 16 We will then probably break for lunch around 12 and then --
- 17 well, we may start, if we can pick up the COG Case 20832 and
- 18 then break for lunch.
- 19 Start after lunch with Texland Petroleum 20894
- 20 and then move to the Hilcorp trio of cases, 20891, 92 and
- 21 93. And then finally, we will hear Marathon 20865, 20866
- 22 and then Novo 20916 and 20917. Any objections?
- 23 (No audible response.)
- 24 (Hearings resumed and Docket 42-19 recessed at
- 25 approximately 5:15 p.m. November 14, 2019. Docket 42-19
