STATEMENT OF THE CASE

Applicant in the above styled cause seeks an order pooling all uncommitted interests in the Wolfcamp formation, Purple Sage-Wolfcamp Gas Pool (Pool code 98220), underlying a standard 640-acre, more or less, horizontal spacing unit comprised of the E/2 of Section 2, Township 26 South, Range 28 East, and the E/2 of Section 35, Township 25 South, Range 28 East, NMPM, Eddy County, New Mexico. Said spacing unit shall be dedicated to the:

- The **Dolores Fed Com 701H** well to be horizontally drilled from a surface hole location in the SE/4SE/4 (Unit P) of Section 2 to a bottom hole location in the NE/4NE/4 (Unit A) of Section 35,
- The **Dolores Fed Com 702H** well to be horizontally drilled from a surface hole location in the SW/4SE/4 (Unit O) of Section 2 to a bottom hole location in the NW/4NE/4 (Unit B) of Section 35, and
- The **Dolores Fed Com 703H** well to be horizontally drilled from a surface hole location in the SW/4SE/4 (Unit O) of Section 2 to a bottom hole location in the NW/4NE/4 (Unit B) of Section 35.

Also to be considered will be the timing of the drilling and completing of said wells, the allocation of the cost thereof, the actual operating costs and charges for supervision, the designation of COG Operating LLC as operator of the wells, and the imposition of 200% charge for risk involved in drilling and completing said wells. Said area is located approximately 9.4 miles south of Malaga, New Mexico.
