The parties haven't yet met in order to draft the pre-hearing order. Additional pooling applications have been filed by Apache in as new Case Nos. 21489, 21490 and 21491.

Under the OCC order, these new pooling applications are a pre-condition for the De Novo Hearing and, as I understand, should be heard at the proposed Dec. 3-4 date along with the other cases. Currently, it looks like, Case Nos. 21489-21491 are on the November 5, 2020, docket.

Would it be possible (if the other parties agree) to move the cases, along with the new cases to the docket for Dec. 3-4, and we will work to get a prehearing order to the Division?
