- 3 by the director of the Oil Conservation Division to conduct
- 4 hearings this morning.
- 5 You will find the docket showing the order in
- 6 which the hearings will be called on the Division web page.
- 7 We have our primary technical reviewer on the line this
- 8 morning. His name is Dylan Rose-Coss. The hearings will be
- 9 recorded and transcribed by Irene Delgado.
- 10 We do have some other technical potential
- 11 examiners on the line as well, and we'll be letting people
- 12 in as they appear in the waiting room. In the event this
- 13 hearing session is disrupted by technical difficulties or by
- 14 mischief, please go to your e-mail and we will find another
- 15 link for you and we'll continue the hearing.
- 16 There is two reminders this morning. One is if
- 17 in fact a case is contested, meaning it will not be

- 20 a formal pleading, but do let her know that, in fact, it

- 22 thing early in the week, that it should be shown as a status

- 6 dismiss the cases in which exhibits are not timely

- 8 Having said that, let's get to the cases.
