LINDA JUDSON AND JUDITH JUDSON**

Judith Judson and Linda Judson (collectively the "Judsons") submit their Pre-Hearing Statement pursuant to the Rules of the Oil Conservation Division.

APPEARANCE

The Judsons are parties in interest in the Application of Spur Energy Partners, LLC ("Spur") in this case. The address for Judith Judson is 57 Marine St., Bronx, NY 10464. The address for Linda Judson is P.O. Box 10885, Midland, TX 79702. The Judsons are represented by the undersigned counsel.

SUMMARY OF THE JUDSONS' POSITION

The Judsons have been negotiating in good faith with Spur Energy Partners, LLC ("Spur") regarding the terms of an oil and gas lease from the Judsons to Spur covering the Judsons' unleased mineral interests in the proposed 320-acre horizontal spacing unit. The Judsons received the latest redline version of the draft lease from Spur on December 29, 2020. Negotiations are continuing. Under the circumstances, it is inappropriate for the Judsons to be force pooled as they are actively working with Spur to lease their interests.


