1 HEARING EXAMINER ORTH: Let's move to our last
2 three matters. This application is 20686. The applicant is
3 Tap Rock Resources, compulsory pooling application for the
4 Painted Pole. Mr. Bruce, are you with us for the applicant
5 in this case?

6 MR. BRUCE: Yes, that is correct.

7 HEARING EXAMINER ORTH: All right. COG has
8 entered its appearance. Mr. Rodriguez, are you here for
9 COG?

10 MR. RODRIGUEZ: Yes, good morning.

11 HEARING EXAMINER ORTH: Good morning. And the
12 other two related cases in the status conference this
13 morning are 21422 and 21423. COG is the applicant in those
14 two cases, compulsory pooling application, Keg Shell Fed Com
15 and Tap Rock represented by Mr. Bruce.

16 So who will be kicking off the discussion for the
17 status conference?

18 MR. RODRIGUEZ: I can start off, if that's all
19 right.

20 HEARING EXAMINER ORTH: Thank you, Mr. Rodriguez.

21 MR. RODRIGUEZ: Sure. So in these contested
22 matters the parties have been engaging in some productive
23 conversation recently regarding the acreage at issue. And
24 both parties are requesting further time to hopefully come
25 to a voluntarily agreement and avoid a contested hearing.

1 MR. BRUCE: And I agree with Mr. Rodriguez. My
2 only problem is my case is so old now I don't even know if I
3 can find my file anymore.

4 MR. RODRIGUEZ: These have been going on a year.

5 MR. BRUCE: So I hope they go away.

6 HEARING EXAMINER ORTH: All right. So are we
7 setting a hearing date this morning or no.?

8 MR. BRUCE: Maybe we should continue it for a
9 month or two months and then have another status conference.

10 MR. RODRIGUEZ: Yeah, I think that works.

11 HEARING EXAMINER ORTH: Who will be doing the
12 continuance? I guess both of you?

13 MR. RODRIGUEZ: I will file the continuances
14 today.

15 MR. BRUCE: Yeah.

16 HEARING EXAMINER ORTH: Okay. Make sure you go
17 through the portal, each of you.

18 MR. BRUCE: Right.

19 HEARING EXAMINER ORTH: And you will do that with
20 Marlene then.

21 MR. RODRIGUEZ: Perfect.

22 HEARING EXAMINER ORTH: Ask two months ahead.

23 MR. BRUCE: Okay. So what is that, the 18th,
24 February 18th?

25 HEARING EXAMINER ORTH: Yes, would be about two

1 months from today.

2 HEARING EXAMINER ORTH: Are you sure you don't
3 want to make it a hearing date instead?

4 MR. BRUCE: What do you think, Michael.

5 MR. RODRIGUEZ: I think that sounds good --
6 yeah, that's fine with me. I mean --

7 MR. BRUCE: That's fine with me. The last I
8 spoke with my clients, I thought they were fairly close to
9 reaching agreement and getting rid of a fight.

10 HEARING EXAMINER ORTH: All right. So we'll
11 issue a prehearing order noting February 18 as the hearing
12 date in these three matters and hope then that we don't need
13 it.

14 MR. BRUCE: Thank you.

15 MR. RODRIGUEZ: That sounds great. Thank you.

16 HEARING EXAMINER ORTH: So we have reached the
17 end of the docket this morning. That was a quick one. Is
18 there anything else we can talk about while we're all --
