- 2 list that we are back to Colgate Operating, Case 21072,
- 3 Modrall Firm.
- 4 MR. HOUGH: Hello again, Mr. Examiner. This is
- 5 Lance Hough from Modrall Sperling on behalf of Colgate
- 6 Operating LLC. I would also like to enter my appearance for
- 7 additional cases I will mention and ask they be
- 8 consolidated. That would be all of the Red Bandana cases,
- 9 and then the Mewbourne's Hemingway cases for this status
- 10 conference.
- 11 So, for the record, that would be eight cases in

- 23 involved, and I think I heard Mr. Bruce's voice. You are

- MR. BRUCE: Chi Energy.
- 20 HEARING OFFICER BRANCARD: Chi.
- 21 MR. BRUCE: I'm entering an appearance also for
- 22 Chi Energy in all eight of the cases. Chi is supporting
- 23 Mewbourne in this matter.
- 24 HEARING OFFICER BRANCARD: Okay.
- MS. LUCK: (Garbled audio) of Holland & Hart on

- 1 behalf of MRC.
- 2 HEARING OFFICER BRANCARD: Okay. So the only one
- 3 we don't have here is Yates Energy and Jalapeno Corp.?
- 4 MR. HOUGH: I believe that's correct.
- 5 HEARING OFFICER BRANCARD: Okay, all right. So
- 6 you can start us off, Mr. Hough. What would you like to do?
- 7 MR. HOUGH: Mr. Examiner, I think we are falling
- 8 into a pattern today. My understanding is that Colgate and
- 9 Mewbourne are negotiating and (inaudible) proceeding to a
- 10 contested docket to set this for a subsequent status
- 11 conference. I think April 22 would be the preferred date
- 12 for a status conference.
- 13 HEARING OFFICER BRANCARD: Mr. Bruce?
- 14 MR. BRUCE: I would rather have it set as a
- 15 hearing date in case they don't settle, but I know the
- 16 parties are in settlement discussions.
- 17 HEARING OFFICER BRANCARD: Okay. Ms. Luck?
- 18 MS. LUCK: I think that EOG is amenable either
- 19 way, if you want to set it for a status or contested. And
- 20 it's my understanding that the parties are working through
- 21 an agreement, so if (garbled audio).
- 22 HEARING OFFICER BRANCARD: Okay. Ms. Salvidrez,
- 23 April 22 is looking a little full, is that right, or how are
- 24 we doing there?
- 25 (No audible response.)

1 HEARING OFFICER BRANCARD: Hope we didn't lose

- 2 Marlene. We may have. Well, let's just set it for April
- 3 22, and we'll set it for hearing, okay? And hopefully that
- 4 will inspire all of you to come to agreements.
- 5 MR. HOUGH: Thank you.
- 6 HEARING OFFICER BRANCARD: Mr. Hough, can you
- 7 draft us a prehearing order?
- 8 MR. HOUGH: Yes, I can put that together.
- 9 HEARING OFFICER BRANCARD: Okay. I would do it
- 10 myself, but I'm not sure I got all of these numbers correct.
- 11 So we are looking at Cases 21072, 21074, 075, 092 and 21325,
- 12 326, 327, 328, and we are setting them for a hearing on
- 13 April 22. Are there any concerns, questions or objections
- 14 from any of the parties?
- 15 HEARING OFFICER BRANCARD: Seeing none, thank
- 16 you. Mr. Hough, if you could have that within a week, that
- 17 would be great.
- 18 MR. HOUGH: Certainly.
- 19 HEARING OFFICER BRANCARD: All right. Thank you
- 20 all for your patience.
