Respectfully, the Division rules do not allow this case to go forward by affidavit under the circumstances. I will be briefing this issue in the motion for status conference or continuance to be filed shortly. In short, 19.15.4.12(A)(1)(b) NMAC expressly provides that a party may go forward by affidavit only when "those owners the applicant has located do not oppose the application." As stated, Cimarex entered an appearance, objecting to the application, and EOG agreed to set this case for a status conference.

EOG should not be allowed to railroad this case to hearing simply because I did not submit an email earlier this week to request that it be put on the docket as a status conference. There is no requirement that such an email be sent. The rule simply states that an applicant can go forward by affidavit only when the application is not opposed. The application is opposed, and the case therefore cannot go forward by affidavit.
