- 6 that time Chevron has been unable to complete the well due
- 7 to the unavailability of an execution crew, and for that
- 8 reason Chevron requests a completion extension for that
- 9 well until April 16, 2022.
- 10 Ms. Rau's affidavit reflects that Notice of
- 11 this application was provided to the interest owners who
- were pooled into this unit, and we have provided with our
- exhibit packet Exhibits C and D., which are a Notice
- 14 Affidavit from our office reflecting that Notice of the
- 15 hearing was provided, as well as Notice of Publication of
- 16 the hearing before the Division today.
- 17 And so with that I would move the admission
- 18 of Exhibits A through D. And I am available if there are
- 19 any questions, but if there are none I would ask that this
- 20 case be taken under advisement by the Division.
- 21 HEARING EXAMINER BRANCARD: Mr. Garcia, any
- 22 questions?
- 23 EXAMINER GARCIA: I have no questions.
- 24 HEARING EXAMINER BRANCARD: Okay. All right.
