- 6 MR. BRUCE: Yes, I'm here for Tap Rock.
- 7 HEARING EXAMINER BRANCARD: Thank you. Are
- 8 there any other parties for this matter, Case 21703?
- 9 (Note: No response.)
- 10 Hearing none, Mr. Bruce you may proceed.
- 11 MR. BRUCE: This is kind of a carbon copy of the
- 12 last case. Order No. 21 -- R-21304 pooled the Bone Spring
- 13 Formation in a proximity tract spacing unit comprised of
