- 2 21687, 21688 and 21689. Titus Oil & Gas is the applicant.
- 3 These are more applications to amend orders. The names of
- 4 the well is Pakse South. Ms. Shaheen, are you here for the
- 5 applicant?
- 6 MS. SHAHEEN: Yes, I am, Madam Examiner. Sharon
- 7 Shaheen of Montgomery and Andrews on behalf Titus Oil & Gas
- 8 Production. As you noted, these are more applications to
- 9 amend previously existing orders to extend the time for
- 10 drilling the Pakse South family of wells.
- 11 These are the Bone Spring wells, and they relate
- 12 to spacing units in -- in the W/2 of Sections 24 and 25, and
- 13 the NW/4 of Section 36, Township 20 South, Range 32 East.
- 14 The current deadline for drilling these wells is
- 15 April 7, 2021. Like the other applicants today, we are here
- 16 due to Covid, due to fluctuating market conditions, and also
- 17 these are federal permits so that existing federal executive
- 18 order is also impacting Titus with respect to these wells.
- 19 On PDF Page 54, you will find my notice of
- 20 affidavit. All of the current owners who were previously
- 21 pooled by the orders -- I will recite the orders as well,
- 22 that might be helpful. The orders that we are talking about
- 23 are Numbers R-21204, R-21205 and R-21206, which were
- 24 previously issued in Case Numbers 20897, 20898 and 20899
- 25 respectively.

Going back to the affidavit of notice at PDF Page

- 2 54, all of the previously forced pooled owners have been
- 3 notified, and there have been no objections to this
- 4 extension of time.
- 5 We've got Exhibit A, which illustrates those
- 6 parties who did receive their notice by certified mailing,
- 7 and there were some who did not, but those were all named
- 8 personally in the notice of publication that was timely.
- 9 And with that, I would request admission of the
- 10 exhibits in the exhibit package and ask the Division to take
- 11 the case under advisement and ultimately extend the deadline
- 12 for drilling to April 7, 2022.
