1 HEARING EXAMINER ORTH: Let's move to Case 21699,

- 2 Cimarex Energy is the applicant. Another request to amend
- 3 an order. James is the name of the well. Mr. Hough, are
- 4 you here for Cimarex?
- 5 MR. HOUGH: Yes, Madam Hearing Examiner.
- 6 HEARING EXAMINER ORTH: And Mr. Rankin, you are
- 7 hearing for EOG?
- 8 MR. RANKIN: Morning, Madam Hearing Officer,
- 9 appearing on behalf of EOG, Adam Rankin of the law firm of
- 10 Holland & Hart, and EOG does not oppose this case proceeding
- 11 by affidavit.
- 12 HEARING EXAMINER ORTH: Thank you very much,
- 13 Mr. Hough.
- 14 MR. HOUGH: So this is to amend Order R-21295 to
- 15 allow for a one-year extension of time to commence drilling
- 16 operations. That would extend the deadline out to April 28,
- 17 2022. And this order pools the Bone Spring formation in the
- 18 E/2 W/2 of Sections 20 and 29 in Township 23 South, Range --
- 19 I'm sorry -- Range 32 East, that's Lea County, and this is
- 20 dedicated to well James 20-29 Fed Com to 38H and 39H.
- 21 And as provided in the packet, Exhibit A is the
- 22 self-affirmed declaration of Kelsi Henriques. The only
- 23 thing I wanted to add here is Kelsi has not previously
- 24 testified before the Division, so as she testified here in
- 25 her self-affirmed declaration, she provided that she

- 1 attended the University of Tulsa, received a bachelor's
- 2 degree in Energy Management with a double concentration of
- 3 upstream and midstream and minor in finance. She graduated
- 4 cum laude in May 2017.
- 5 She has worked as a landman since June of 2017.
- 6 She also has some prior experience that dates back to 2014
- 7 on land matters which included intern work at Concho for
- 8 several summers that are related to the Permian Basin of New
- 9 Mexico.
- 10 She first worked as a landman at Concho from June
- 11 2017 to October 2020, and she worked as a landman at Cimarex
- 12 from December of 2020. She also provides that she is
- 13 working on behalf of Cimarex in New Mexico, primarily in the
- 14 Delaware Basin and she is familiar with these applications.
- 15 So at this time, I would tender Ms. Henriques as an expert
- in petroleum land matters.
- 17 HEARING EXAMINER ORTH: Any questions,
- 18 Mr. Rankin, about that?
- MR. RANKIN: no questions.
- 20 HEARING EXAMINER ORTH: All right. Thank you.
- 21 She is so recognized.
- MR. HOUGH: I will add, her resume is attached to
- 23 her declaration. So as she provides in her declaration, she
- 24 states good cause exists for the extension of time due to
- 25 the market conditions. Cimarex has adjusted its drilling

- 1 schedule for this development area as well.
- 2 It is further provided in the hearing packet
- 3 Exhibits A-1 and A-2 are the applications in this case and
- 4 the orders I have discussed.
- 5 Exhibit B is my affidavit of notice, and I have
- 6 reflected in B-1 through B-3 that notice was timely mailed
- 7 to the interested parties, as well as published in a
- 8 newspaper of local circulation timely.
- 9 So unless there are any questions, I would ask
- 10 that these exhibits be admitted into the record and this
- 11 matter be taken under advisement.
- 12 HEARING EXAMINER ORTH: Thank you, Mr. Hough.
- 13 Mr. Rankin, any questions?
- MR. RANKIN: No questions and no objection to the
- 15 exhibits being admitted into the record.
- 16 HEARING EXAMINER ORTH: Thank you. Mr. Lamkin,
- 17 any questions?
- 18 TECHNICAL EXAMINER LAMKIN: I have no questions.
