- 2 21702, Cimarex Energy, the applicant. More requests to
- 3 amend earlier orders. The wells are Grama Ridge and West
- 4 Grama Ridge. Mr. Hough, I trust you are here for Cimarex?
- 5 MR. HOUGH: That's correct, Madam Examiner.
- 6 HEARING EXAMINER ORTH: Let me pause in the event
- 7 there are other entries?
- 8 (No audible response.)
- 9 HEARING EXAMINER ORTH: No? Please go ahead.
- 10 MR. HOUGH: In these two cases Cimarex seeks to
- 11 amend Orders 21297 and 21298 to allow for a one year
- 12 extension of time to commence drilling operations. A one
- 13 year extension would meet the deadline for both of these
- orders or these orders of April 28, 2022.
- Order Number R-21297 will be Bone Spring
- 16 formation in the W/2 E/2 of Sections 6 and 7. That's
- 17 Township 22 South, Range 34 East in Lea County.
- 18 Order 21298 pooled the Bone Spring formations in
- 19 the E/2 E/2 of Section 7, Township 22 South, Range 34 East
- 20 in Lea County. I will say this, Order 21297, that acreage
- 21 is dedicated to the West Grama Ridge 76 Fed Com 1H well.
- 22 And the 21298 order is dedicated that acreage to the West
- 23 Grama Ridge 7 Fed Com 2H well.
- Now, as provided in the hearing packet, Exhibit A
- 25 is the self-affirmed declaration of John Coffman. Also

1 provided here as he provided in his declaration, he has not

- 2 previously testified before the Division. It's a similar
- 3 matter as I testified before.
- 4 I want to walk through his qualifications for
- 5 him. His resume is also attached immediately to his
- 6 declaration. His declaration provides he attended Texas
- 7 University, received a bachelor of business administration,
- 8 energy and commerce, and graduated in May of 2018.
- 9 His experience in land matters dates back to May
- 10 2014 where he previously worked as a land (unclear) oil &
- 11 gas, and then as a contract land man at Conquest Energy, has
- 12 now worked as a landman for Cimarex since May of 2018.
- 13 He also provides that he has worked for Cimarex
- 14 involving the Permian Basin in New Mexico, primarily Lea
- 15 County, and he is familiar with the application.
- 16 So with that information, I would ask at this
- 17 time that he be -- I will tender him as an expert in
- 18 petroleum land matters.
- 19 HEARING EXAMINER ORTH: He is so recognized.
- 20 MR. HOUGH: Thank you. Moving on, he provides in
- 21 his declaration good cause exists for Cimarex's request for
- 22 extension of time due to current market conditions, and he
- 23 also provides that Cimarex adjusted their drilling schedule
- 24 as a result of the market conditions.
