- 2 next three matters. This is Mewbourne Oil, 21706, 21707,
- 3 21708, Mewbourne Oil is the applicant. These are requests
- 4 to amend earlier orders.
- 5 Mr. Bruce, you are here for the applicant?
- 6 MR. BRUCE: Yes, I am.
- 7 HEARING EXAMINER ORTH: Let me pause for a moment
- 8 in the event there are other entries of appearance.
- 9 (No audible response.)
- 10 HEARING EXAMINER ORTH: No. If you would then
- 11 please go ahead.
- 12 MR. BRUCE: These three cases involve Mewbourne's
- 13 Foxhole wells, the first one, 21706, seeks to amend Order
- 14 R-21187, 21187, which force pooled the Wolfcamp formation in
- 15 the S/2 N/2 of Section 25 and S/2 NE of 26 of 20 South, 28
- 16 East.
- 17 The second case, 21707, seeks to amend Order
- 18 R-21214 which concerned the Wolfcamp in the N/2 S/2 of
- 19 Section 25, and the N/2 SE of Section 26, same township and
- 20 range.
- 21 And then Case 21708 involves Order R-21217 which
- 22 concerns the S/2 S/2 of Section 25, and S/2 SE of Section
- 23 26, same township and range.
- 24 Attached is the affidavit of Adriana Salgado,
- 25 Mewbourne's landman who has previously qualified and

1 requesting permission to amend the orders to extend the

- 2 drilling deadlines for one year. The current drilling
- 3 deadlines expire in early to mid April about a month from
- 4 now.
- 5 And they also seek to incorporate the new, the
- 6 new form of order that was announced last spring or summer,
- 7 and she -- the reason for this is, as people have
- 8 complained about in many of these hearings is mainly market
- 9 conditions, but of course nowadays with the suspension of
- 10 approval of APDs that can be an issue, too.
- 11 So there is her affidavit -- landman's
- 12 affidavit, the notice -- my notice affidavit, and I did not
- 13 get a green card back from the only person pooled, the only
- 14 person subject to the pooling order yet and publication
- 15 notice which cured that issue.
- 16 In the original hearings, there were a number of
- 17 people force pooled, but all of them came to terms except
- one and that was the Petroleum Synergy Group which was given
- 19 notice of these applications to amend the pooling orders.
- 20 And with that, I think the application is complete, and I
- 21 move the admission of Exhibits 1 through 4 and ask that the
- 22 matters be taken under advisement.
- 23 HEARING EXAMINER ORTH: All right. Thank you,
- 24 Mr. Bruce. Mr. Lamkin, do you have any questions?
- 25 TECHNICAL EXAMINER LAMKIN: I just have one
