And Page 36 also shows the list of the overriding royalty 3 4 interest in these proposed spacing units. 5 Exhibit C, which is my affidavit, shows that 6 everyone received -- we got a green card from everyone, so 7 it was not necessary for us to publish in Lea County. 8 Exhibit B has a number of geological exhibits 9 that Ms. Childress provided. She concludes at Paragraph 12 10 of Exhibit B that each tract is going to contribute to the well more or less equally. 11 12 So that's pretty much what the conclusion is in 13 terms of pooling in this case. With that, we would offer 14 Exhibits A, B, C, and of course the compulsory pooling 15 checklist which is the last item in the packet.
