2 I'm here on behalf of Mewbourne. JAMES BRUCE: HEARING EXAMINER BRANCARD: Thank you, 3 Mr. Bruce. 4 Are there any other entries in case 21770? 5 6 Hearing none, Mr. Bruce, you may proceed. JAMES BRUCE: Mr. Examiner, in this case, 7 8 Mewbourne seeks to force pool the western half of the Section 35 and west half of Section 26 in 23 South, 9 28 East for purposes of drilling three Wolfcamp wells. 10 This is, again, in the Purple Sage Wolfcamp 11 12 gas pool. 13 The exhibit package contains the usual 14 exhibits. There's -- the land man's affidavit does contain ownership information on the well units. 15 The only party being pooled is Chevron USA, 16 Inc., as you can see from Attachment B to the land 17 man's affidavit. It contains all the rest of the usual 18 exhibits from the geologist and goes through the 19 20 qeology. 21 On three of these packages, and this is one of 22 them, one -- when I printed out the cross-section -- I tried numerous times, and it printed out as black. 23 24 I will download the -- in this case, it's Attachment B to the land man's affidavit. 25 It's hard to
