And I believe that the case can proceed 5 6 once those are resolved. HEARING EXAMINER BRANCARD: It sounds like 7 8 there's a good chance this will not go to a contested hearing, but we need to set a date. 9 10 DARIN SAVAGE: That's the hope, Mr. Examiner. HEARING EXAMINER BRANCARD: Okay. Well, 11 why -- how about if we just put this on the July 15th 12 13 docket, and hopefully you can resolve it by then. 14 JAMES BRUCE: That would be fine with us. DARIN SAVAGE: That sounds good. Thank you. 15 HEARING EXAMINER BRANCARD: Okay. Once again, 16 are there any other interested parties in these four 17 18 cases? 19 Hearing none, Cases 21884, 21885, 21886, 21887 are continued to July 15th. And I will prepare a 20 21 pre-hearing order for that. Please file continuances. 22 Thank you. (Hearing concluded) 23 24 25
