**APPLICANT'S STATEMENT OF CASE**

Spur seeks an order pooling additional interest owners under the terms of Order No. R-21622. Division Order No. R-21622, entered on March 15, 2021, in Case No. 21675, created a standard 320-acre horizontal spacing unit in the Yeso formation comprised of the S/2 of Section 12, Township 19 South, Range 25 East, NMPM, Eddy County, New Mexico. The Order

dedicated the above-referenced horizontal spacing unit to the following proposed initial wells: (1) the **Rose South #10H well**, (2) the **Rose South #50H well**, (3) the **Rose South #60H well**, (4) the **Rose South #11H well**, (5) the **Rose South #51H well**, and (6) the **Rose South #20H well**.

Since the entry of Order No. R-21622, Spur has determined that there are additional interest owners in the Unit who were not provided notice of the hearing in Case No. 21675, and as a result, whose interests were not pooled by the terms of Order No. R-21622.
