CONOCOPHILLIPS COMPANY'S MOTION FOR CONTINUANCE

ConocoPhillips Company ("Conoco") requests a continuance of these matters to the Oil Conservation Division's July 15, 2021 hearing docket. In support of this request, Conoco submits the following.

1. Longfellow Energy, LP ("Longfellow") and Spur Energy Partners, LLC ("Spur") filed the above-referenced competing compulsory pooling applications covering the N/2 of Section 13 and the NE/4 of Section 14, Township 17 South, Range 28 East, Eddy County, New Mexico. Conoco is a working interest owner in the spacing units proposed by Longfellow and Spur.

2. The Division issued an amended pre-hearing order setting these cases for hearing on June 17, 2021.

3. On June 3, 2021, Spur provided Conoco with revised well locations for several of the wells at issue in Case No. 21733.

4. Conoco is evaluating the competing proposals and requires additional time to do so, especially in light of the revised well locations. As a result, a continuance is necessary to protect Conoco's correlative rights.

5. Spur supports this motion for continuance.

6. Longfellow opposes this motion.

For the foregoing reasons, Conoco requests the Division grant its motion to continue Case Nos. 21651 and 21733 to the July 15, 2021 hearing docket.
