- 3 No. 4 on today's agenda. It is OCD Case No. 21900, notice
- 4 of Violation issued to Bar V. Barb, LLC.
- 5 For the Division?
- 6 MR. AMES: Mr. Hearing Examiner, Eric Ames for
- 7 OCD.
- 8 HEARING EXAMINER BRANCARD: Thank you. Is there
- 9 anyone here on behalf of the Respondent or elsewise
- 10 wishing to make comment on this case? (Note: No
- 11 response.)
- 12 Hearing none, you may proceed, Mr. Ames.
- 13 MR. AMES: Thank you, Mr. Hearing Examiner.
- OCD proposes to proceed in the same manner
- 15 that we have proceeded in all the previous cases for which
- 16 parties have not appeared.
- 17 OCD begins by calling Mr. Daniel Sanchez.
- 18 HEARING EXAMINER BRANCARD: Thank you.
- JOSE DANIEL SANCHEZ,
- 20 having been duly sworn, testified as follows:
- 21 EXAMINATION
- 22 BY MR. AMES:
- 23 Q. Daniel, please state your name for the record.
- 24 A. Jose Daniel Sanchez.
- Q. And Daniel, where do you work, how long have you

- 1 worked there, and what do you do?
- 2 A. I work for the Oil Conservation Division, a
- 3 Division of the energy, minerals and Natural Resources
- 4 Department. I have been in that position for over 16
- 5 years, and that position being Administration and
- 6 Compliance Bureau Chief.
- 7 Q. Thank you. Did you prepare testimony for this
- 8 hearing?
- 9 A. Yes.
- 10 Q. Is that testimony presented in Section 2, Direct
- 11 Testimony of the OCD's Prehearing Statement?
- 12 A. Yes, it is, let's review the violations and
- 13 sanctions in your Direct Testimony
- 14 What is the first violation alleged in the
- 15 NOV?
- 16 A. The first violation is or Rule 19.15.5.9
- 17 (A)(4)(a), which is a violation of the inactive well rule.
- 18 Bar V Barb has more inactive wells than required by the
- 19 rule.
- Q. What sanction does OCD propose for this
- 21 violation?
- 22 A. We are requesting an Order requiring Bar V Barb
- 23 to plug and abandon 13 of the inactive wells identified in
- 24 Table 1, and, if not, allow the OCD to do so.
- 25 And we're also asking for a civil penalty

- 1 of \$3900.
- 2 Q. Thank you. Is there a second violation here?
- 3 A. Yes. That is of Rule 19.15.8.9(D) and that's
- 4 deficient or insufficient financial assurance for the
- 5 wells.
- 6 Q. Does OCD propose a sanction for this violation?
- 7 A. Yes. We are asking for an Order requiring Bar V
- 8 Barb to either submit a T.A. Blanket Bond in the amount of
- 9 \$150,000 to cover three wells, or to increase the current
- 10 amounts for those three wells to the proper amounts.
- 11 We are also asking or a civil penalty in
- 12 the amount of \$900.
- 13 Q. Thank you. Let's move on to Section 3 in the
- 14 Prehearing Statement, which is a list of the exhibits
- offered by OCD in this case. Could you review those
- 16 exhibits for the record.
- 17 A. Exhibit 1 is my Curriculum.
- 18 Exhibit 2 is the Notice of Violation.
- 19 Exhibit 3 and 4 the civil penalty
- 20 calculations.
- 21 Exhibit 5 is the Return Certified Mail sent
- 22 out for the NOV.
- 23 Exhibit 6 is the electronic mail return for
- 24 the NOV.
- MR. AMES: Thank you, Daniel.
