Page 3 1 (Time noted 9:11 a.m.) 2 EXAMINER BRANCARD: Call Case 21959, Mewbourne 3 Oil Company. Mr. Bruce. 4 MR. BRUCE: Yes, Mr. Examiner. I'm representing 5 Mewbourne. EXAMINER BRANCARD: Thank you. I don't see any 6 7 other entries. Are there anyone else interested in Case 8 21959? Hearing nothing, Mr. Bruce you may proceed. 9 MR. BRUCE: In this matter Mewbourne seeks to 10 force pool the south half/southeast of Section 29 and the 11 12 south half/south half of Section 28, 18 South, 29 East, as 13 to the Bone Spring Formation for the Pavo Frio well. I think there is about seven or eight total Pavo Frio wells 14 15 in this general area. 16 Exhibit 1 is the application and proposed 17 Notice. Exhibit 2 is the statement of Tyler Jolly 18 19 the landman. The only person being force pooled are the Donna Bliven or her heirs or devisees, who own 20 21 approximately a .16 percent interest in the well unit. Mewbourne has made an effort over the years 22 on locate her. She is believed to be deceased. Mewbourne 23 24 has been in touch with people that Mewbourne believes are 25 her relatives but they never respond to anything, never

Page 4 give any information on what happened to her. So that is 1 2 the reason for filing the application. 3 The landman's affidavit contains the usual 4 land plats, C-102s. You can see Mewbourne did send a 5 Proposal Letter out, and it was received, as was my proposal -- or I should say my Notice Letter, which is 6 7 marked Exhibit 4, but there's never any response. 8 Then the statement of Charles Crosby, the geologist, containing the usual exhibits pertaining to the 9 10 Third Bone Spring Sand, which is the target zone of this 11 well. 12 As I said, Exhibit 4 is my Affidavit of Notice, but Exhibit 5 is also an Affidavit of Publication 13 14 from the Carlsbad newspaper. 15 And Exhibit 6 is the Application Checklist. 16 I believe the exhibit package is complete, 17 and I would ask that Exhibits 1 through 6 be admitted and the matter be taken under advisement. 18 19 EXAMINER BRANCARD: Thank you. 20 Mr. Lowe, any questions? 21 EXAMINER LOWE: I have no questions. Thank you. 22 HEARING EXAMINER BRANCARD: Once again, is there any other persons here today interested in Case 21959, 23 24 Mewbourne Oil Company, Pavo Frio well. (Note: Pause.) 25 Hearing none, the exhibits will be admitted
