LUCK: Thank you. 12 This case is similar to the prior case that 13 we just reviewed in that EOG is also seeking to pool a 14 record title owner into this Unitization; however, this is 15 a vertical spacing unit. 16 EOG understood prior to the hearing there 17 would be no objection and also filed its exhibit packet on Tuesday. The exhibit packet includes the standard 18 19 exhibits, starting off with a copy of the Pooling Application Checklist as Exhibit A, followed by a copy of 20 21 the application as Exhibit B. Exhibit C is the affidavit of Janet 22 Richardson, who again is EOG's landman for this project. 23 24 She testifies that EOG is seeking an Order pooling a 25 record title owner in this Wolfcamp Unit, which underlies

Page 4 a standard 320-acre piece of property in the west half of 1 2 Section 25. This is all in Township 19 South, Range 24 3 East, in Eddy County New Mexico. EOG is seeking to dedicate this unit to the 4 March AMT Fed Com 1H well, and the details of that 5 vertical well are provided in Ms. Richardson's land 6 affidavit, which is Exhibit C. 7 8 She also provides a copy of the C-102 as Exhibit C-1. That C-102 has the pool code and the pool 9 name for the well. 10 11 And then her C-2 identifies the record 12 title owner that EOG is seeking to pool into this Unit. 13 And then finally her Exhibit C-3 is a copy 14 of the proposed Communitization Agreement for this 15 acreage. 16 Finally in the packet are Exhibits D and E, 17 which just reflect our office provided Notice to the interest owner to be pooled in the unit. 18 19 And with that I would the move the admission of EOG's Exhibits A through E and request that 20 21 this case also be taken under advisement. 22 EXAMINER BRANCARD: Thank you.
