- 19 this project for Mewbourne. He does request that the
- 20 deadline be extended to July 29, 2022. As usual, market
- 21 conditions and the epidemic, and everything that went on
- 22 over the last year plus, slowed down drilling, and so a
- 23 lot of things were put on hold for a while.
- 24 Mewbourne does plan on drilling this well,
- 25 as well as a related, some related wells in the same

- 4 Exhibit 3 is my Affidavit of Notice. All
- 5 of the parties originally pooled in this case were

- 7 One thing I would note is that one of the
- 8 parties -- I should say two entities, Thru Line Oil & Gas
- 9 and XTO Energy were originally force pooled but they have
- 10 signed a JOA and so are no longer subject to the pooling
- 11 orders.
- 12 And then finally Exhibit 4 is an Affidavit
- 13 of Publication. So between the Certified Letter and the
- 14 Affidavit of Publication everyone did receive Notice.
