- 2 EXAMINER BRANCARD: With that we will call Cases
- 3 22116, 22118, 22119, Franklin Mountain Energy.
- 4 MS. BENNETT: Deana Bennett on behalf of
- 5 Franklin Mountain, and I'm hoping you can hear me better
- 6 and my lips are moving with the video. I have switched to
- 7 headphones, so Ms. Macfarlane, if this is better, let me
- 8 know.
- 9 (Note: The reporter responded.)
- 10 MS. BENNETT: Thanks for alerting me to the
- 11 problem. I appreciate it.
- 12 EXAMINER BRANCARD: Well,.
- 13 A. Thank you for dealing with the issue.
- 14 Are there any other interested persons in
- 15 Cases 22116, -118, -119? (Note: Pause.)
- 16 Hearing none, you may proceed, Ms. Bennett.
- MS. BENNETT: Thank you.
- In these cases Franklin Mountain Energy is
- 19 seeking an extension of time to commence drilling the
- 20 wells under three Orders that were previously issued by
- 21 the Division. Those are Order Nos. R-20945, R-20942 and
- 22 R-20943.
- I have submitted exhibits, and in the
- 24 exhibit packets are -- the exhibit packets are virtually
- 25 identical. They include the affidavit of -- excuse me,

- 1 the Self-Affirmed Declaration of Shelly Albrecht. And Ms.
- 2 Albrecht is a land professional who has previously
- 3 testified before the Division and her credentials have
- 4 been accepted as a matter of record.
- 5 Behind her Declaration I have included the
- 6 application that was submitted in this case, Order No.
- 7 209 -- the Order for each case that was previously
- 8 admitted -- excuse me, entered -- and then the OCD Order
- 9 granting the first extension in these cases.
- 10 So this is a request for a second
- 11 extension.
- 12 I have also included behind Ms. Albrecht's
- 13 Declaration the expert testimony in a Spur hearing where
- 14 the Division granted a similar second extension request
- 15 for the same reasons that Ms. Albrecht identifies, or
- 16 similar reasons that Ms. Albrecht identifies in her
- 17 affidavit.
- 18 Finally I have included a Notice Affidavit,
- 19 and then I have also included a Proposed Revisesd
- 20 Exhibit A, which I will discuss in a moment.
- 21 But before getting to that, I just did want
- 22 to point out to the Division, in Ms. Albrecht's
- 23 Self-Affirmed Declaration she does discuss the reasons why
- 24 Franklin Mountain Energy is seeking a second extension of
- 25 time. There is multiple reasons for that. One is, of

1 course, the disruption that all operators have encountered

- 2 based on Covid and the change in market conditions. In
- 3 addition, though, Franklin has determined to batch drill
- 4 its wells and so has decided that will be more efficient,
- 5 and so is seeking an extension of time to facilitate the
- 6 batch drilling.
- 7 And finally, in three cases which are not
- 8 being heard today but are now set for the September 23rd
- 9 hearing, Franklin Mountain Energy is asking to pool -- to
- 10 add another unit to this set of units, and also asking to
- 11 add two wells to existing Orders, again for the purpose of
- 12 batch drilling. So because of those changes to the
- 13 Drilling Plan, Franklin Mountain Energy is also seeking
- 14 the second extension.
- 15 So in Ms. Albrecht's Declaration she does
- 16 detail the reaons for the extension requests, all three of
- 17 those reasons.
- I also just wanted to point out I did
- 19 attach a Revised Exhibit A for these three cases, and the
- 20 reason for attaching that Revised Exhibit A is because as
- 21 Ms. Albrecht was preparing for the hearing in these
- 22 matters, she noticed that the Pool and Pool Code had been
- 23 changed on the APD, and so what was was originally Third
- 24 Bone Spring and a Bone Spring Pool has been changed to a
- 25 Wolfbone Pool.

1 So to address the difference between the

- 2 Compulsory Pooling Order on the one hand and the APDs on
- 3 the other, I prepared Revised Proposed Exhibit A to update
- 4 the Compulsory Pooling Order to match the APDs. I did
- 5 that out of an abundance of caution, or sort of belts and
- 6 suspenders, for the Division's records, but if the
- 7 Division has a different way they would like to address
- 8 that change to the Pool Code for Exhibit A, I'm more than
- 9 happy to address that however the Division sees fit, and
- 10 I'm definitely open for questions on those changes.
- But the changes to the Pool Code do not
- 12 impact the request for the extension of time, so my
- 13 primary request here, and Franklin Mountain Energy's
- 14 primary request is to extend the time for Franklin
- 15 Mountain Energy to drill the initial wells under these
- 16 Orders for a year, which would be through the end of
- 17 October, 2022.
- 18 With that I'll stop my presentation, and
- 19 again I stand for questions.
- 20 EXAMINER BRANCARD: Thank you.
- 21 Mr. Simmons, I know Ms. Bennett has chatted
- 22 with Mr. Garcia on these Pool Code issues a little bit,
- 23 so...
- 24 EXAMINER SIMMONS: No, I don't have any
- 25 questions.

I guess do you want an amended exhibit

- 2 attached to the Order reflecting that new Pool Code? Is
- 3 that what your intention is, Deana?
- 4 MS. BENNETT: That's right. That's what I was
- 5 thinking would be the most efficient way to address this.
- 6 The other option I thought of myself was submitting a
- 7 motion nunc pro tunc asking the Division to amend the
- 8 Exhibit A, but while we were having this hearing today, I
- 9 thought it might just be more efficient to just take care
- 10 of this today versus in a subsequent administrative
- 11 proceeding.
- 12 EXAMINER SIMMONS: Yes, nunc pro tunc is an
- 13 anthem with Mr. Brancard. So yes, we will try to handle
- 14 it informally through just appending the amended exhibit,
- 15 if we can. Thank you.
- MS. BENNETT: Thank you very much.
- With that I would ask, before I forget,
- 18 that the exhibits in Case No. 22116, Case No. 22118, and
- 19 Case No. 22119 be admitted into the record, and that these
- 20 cases be taken under advisement.
- 21 EXAMINER BRANCARD: Thank you.
- 22 And so are there any other interested
- 23 persons for Cases 22116, 22118, 22119? (Note: Pause.)
- 24 Hearing none, these cases will be taken
- 25 under advisement and the exhibits will be admitted into

- 1 the record. Thank you.
- 2 And I think you have opened a little bit of
- 3 a box of Pandora's by bringing up these Pool Code issues
- 4 with us, so...
- 5 MS. BENNETT: Yes. I look forward to closing
- 6 that box September 23rd when our hearing of the next three
- 7 cases are coming up for hearing.
- 8 EXAMINER BRANCARD: Seems that people who deal
- 9 with Pool Codes aren't necessarily talking or
- 10 communicating with the people doing Pooling Orders; nor do
- 11 our I.T. systems communicate with each other. So we may
- 12 have a little bit of work to do there. Thank you for
- 13 bringing up that issue, actually.
- 14 MS. BENNETT: Thank you very much. Thanks for
- 15 your consideration of the issue. Much appreciated.
