Devon Energy Production, LP (“Devon”) (OGRID No. 6137) seeks administrative approval of an unorthodox well location for its **Shetland 11-2 Fed State Com #732H Well** (API No. 30-015-47159) to be completed within the Purple Sage Wolfcamp Pool (98220) underlying the W/2 of Sections 2 and 11, Township 26 South, Range 31 East, N.M.P.M., Eddy County, New Mexico.

This well will be drilled from a surface location 350 feet from the south line and 2140 feet from the west line (Unit N) of Section 11 to a bottom hole location 20 feet from the north line and 2310 feet from the west line (Unit C) of Section 2. The first take point will be located 100 feet from the south line and 2310 feet from the west line (Unit N) of Section 11, and the last take point will be 100 feet from the north line and 2310 feet from the west line (Unit C) of Section 2.

Pursuant to Division Order R-14262, this acreage is governed by the Special Rules for the Purple Sage-Wolfcamp Gas Pool which provide for wells in the Wolfcamp formation in Eddy County to be located no closer than 330 feet to the outer boundary of the spacing unit. The completed interval for the **Shetland 11-2 Fed State Com #732H Well** will be unorthodox because it is closer than 330 feet to the northern and southern boundaries of the spacing unit. Approval of the unorthodox completed interval will allow Devon to use its preferred well spacing plan for horizontal wells in this area and thereby prevent waste.

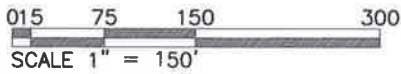

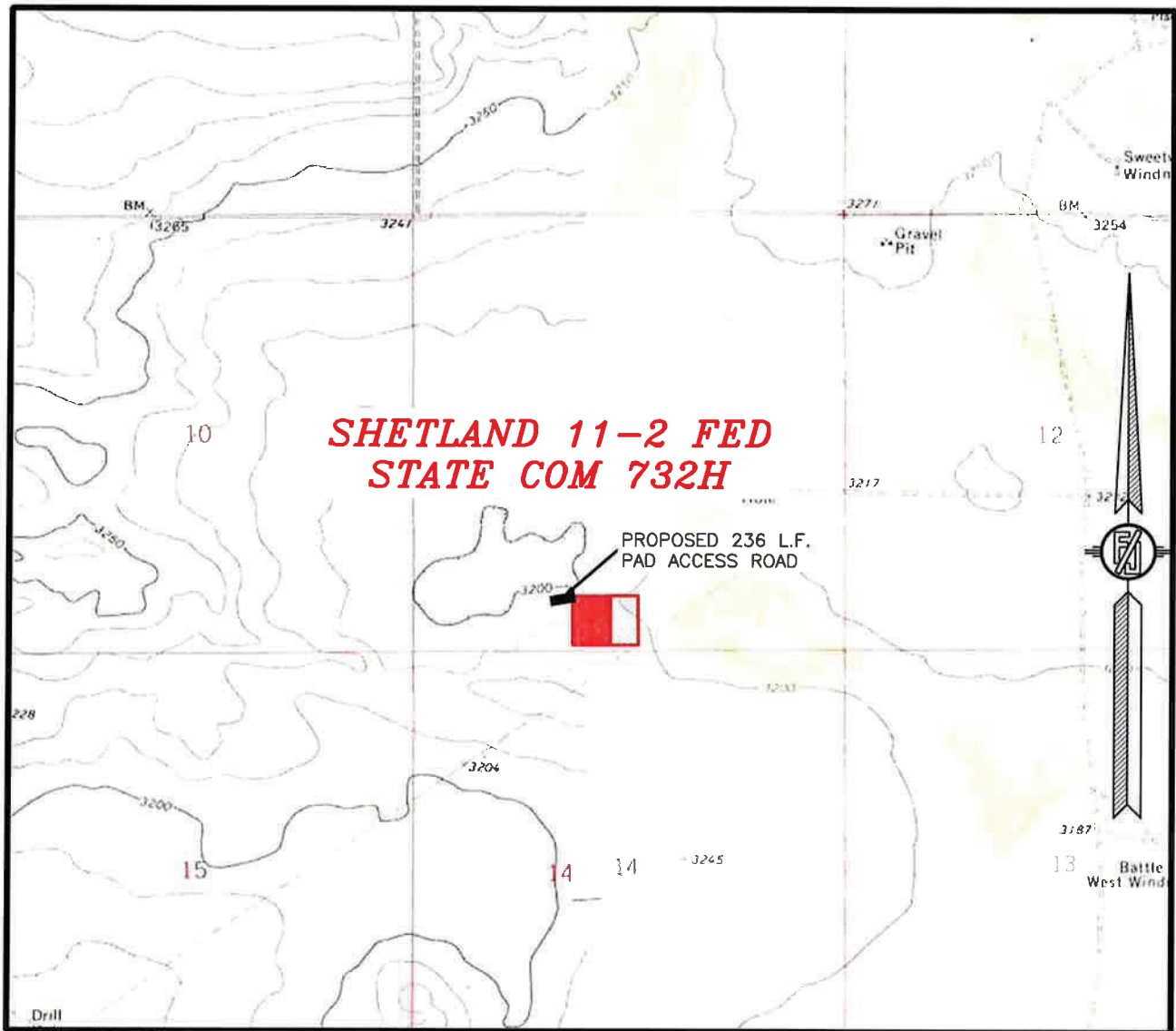

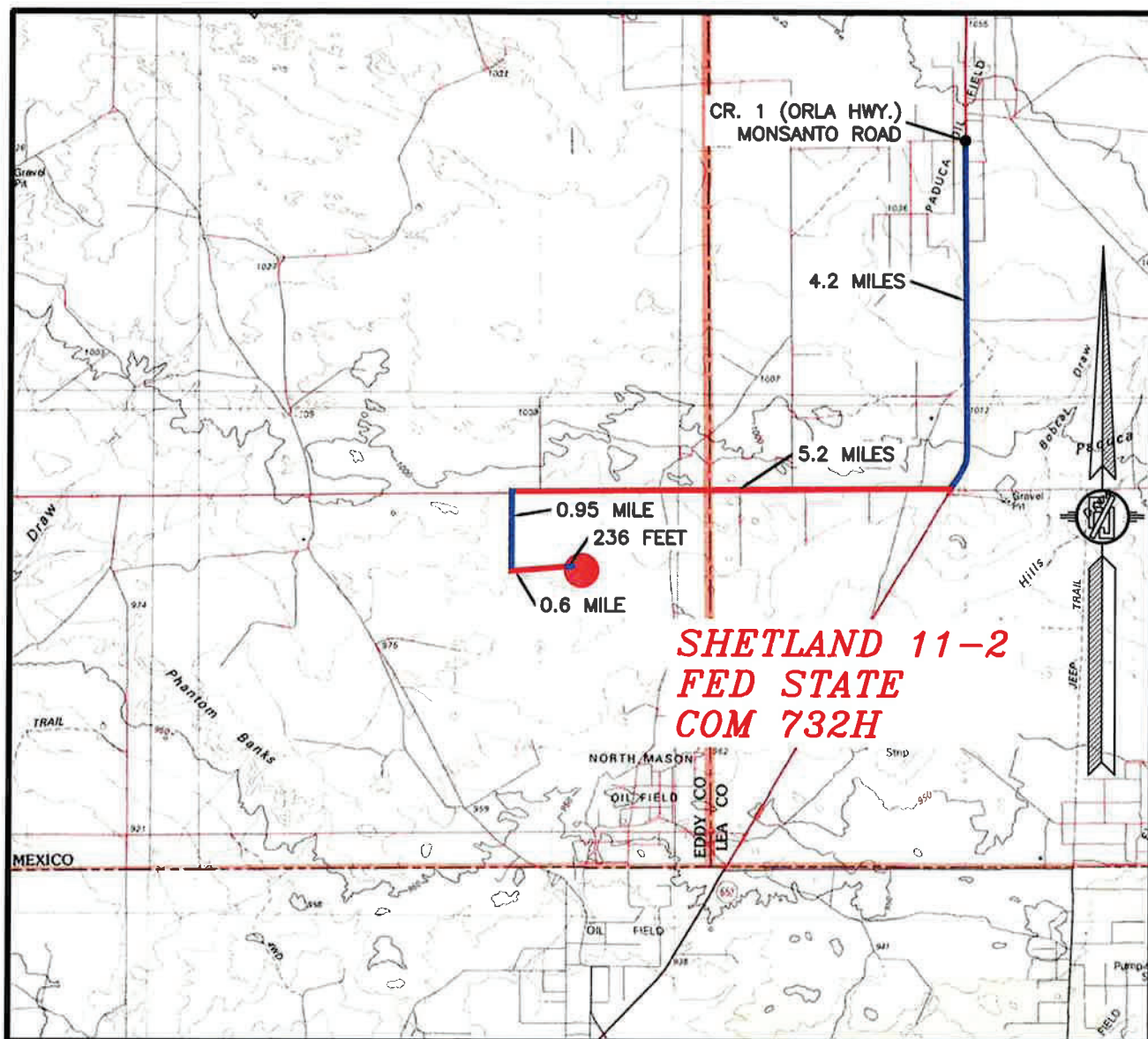

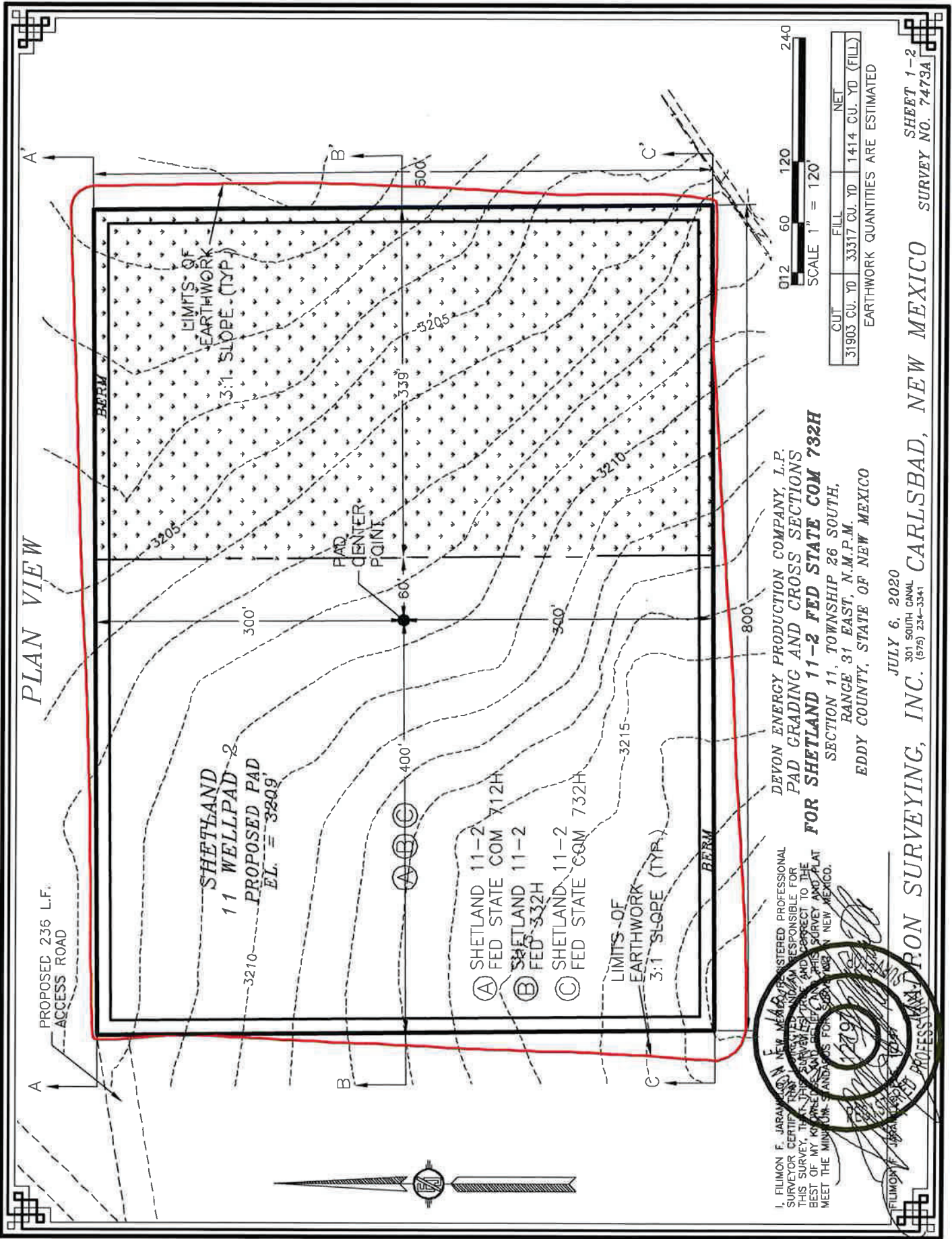
