2 EXAMINER BRANCARD: With that I call Case 22198,
3 Marathon Oil Permian.

4 MS. BENNETT: Thank you. This is Deana Bennett
5 on behalf of Marathon Oil Permian, LLC.

6 EXAMINER BRANCARD: Are there any other
7 interested persons for Case 22198? (Note: Pause.)
8 Hearing none, you may proceed, Ms. Bennett.

9 MS. BENNETT: Thank you. Case 22198 involves
10 Marathon's Fiddle Firewells, and in this case Marathon is
11 requesting a one-year extension of time to commence
12 drilling the initial wells under the Order. This is
13 Marathon's first request under this Order.

14 And I did submit the exhibits through the
15 portal, and included with the exhibits are the Declaration
16 of Clayton W. Rule, and Mr. Rule is a landman at Marathon
17 and he has previously testified before the Division and
18 his credential have been accepted as a matter of record.

19 Behind his Declaration I have included the
20 original Order, Order 21486, which Marathon is seeking to
21 re-open to amend to allow Marathon an additional one year
22 to commence drilling the initial well under the Order.
23 And then Exhibit 3 is my Notice Affidavit showing that
24 Notice of this hearing was timely mailed and published.

25 In this case, like the other cases,

1 Marathon is seeking an extension of time due to changes in
2 Marathon's drilling schedule occasioned by Covid 19 and
3 the disruptions in the market conditions, which continue
4 to delay Marathon's plans.

5 Under the Order Marathon was required to
6 drill the initial well by October 12, 2021, and so
7 Marathon is requesting an extension of time through
8 October 12, 2022.

9 With that I ask that the exhibits in Case
10 No. 22198 be admitted into the record and that this case
11 be taken under the advisement. And I stand ready for any
12 questions -- that I can answer, that is.

13 MR. BRANCARD: Well, we may have some you can.

14 Mr. Rose-Coss, any questions?

15 EXAMINER ROSE-COSS: There's not going to be any
16 questions you can answer or not answer for me.

17 MS. BENNETT: Thank you.

18 EXAMINER BRANCARD: All right. With that are
19 there any other interested persons for Case 22198, Fiddle
20 Fire well? (Note: Pause.)

21 Hearing none, Case 22198 will be taken
22 under advisement and the exhibits will be admitted into
23 the record. Thank you.
