Page 3 1 (Time noted 10:03 a.m.) 2 EXAMINER BRANCARD: With that I call Case 22245, 3 Mewbourne Oil Company. 4 MR. BRUCE: Jim Bruce on behalf of Mewbourne 5 here. 6 EXAMINER BRANCARD: Are there any other 7 interested persons for Case 22245? (Note: Pause.) Hearing none, please proceed, Mr. Bruce. 8 MR. BRUCE: In this case Mewbourne seeks to 9 force pool the south half/northwest quarter of Section 29 10 and the south half/north half of Section 30, 18 South, 11 12 29 East, solely for the purpose of pooling a record title 13 owner, a deceased record title owner so that the Bureau of 14 Land Management will approve a communitization agreement for this well. 15 16 The well has been drilled, and if you go 17 through the landman's affidavit, Exhibit 2, you will see Attachment B to that letter is a Notice from the BLM to 18 Mewbourne stating that Federal Lease NM 056427 as a 19 deceased record title owner, a gentleman named W.T. Wynn, 20 21 and they required -- they recommended a forced pooling so 22 that they could approve the communitization agreement. 23 And that's it in a nutshell. Mewbourne did 24 send a request to the last-known address of Mr. Wynn, it 25 was returned as -- I sent it Certified Mail to that

Page 4 address. Never got a green card back, and I did publish 1 2 Notice. And once again a day late and a dollar short 3 here. This one also was published on October 23rd. 4 So I would ask that Exhibits 1 through 5 minus the Pooling Checklist be admitted, and continue it 5 to December 2nd solely to let the Notice period play out. б 7 EXAMINER BRANCARD: Thank you. Mr. McClure, any questions? 8 9 EXAMINER McCLURE: Yeah. I guess can you detail any of what went on to try to find descendents of Mr. 10 Wynn's estate? 11 12 MR. BRUCE: Uh, yeah. And if you would like 13 more info on that, I can get more to supplement the record 14 on that. 15 But one problem, though, is that when it 16 comes to a record title owner like this, unless the family 17 goes and does a probate and gets named the record title owners, it's still in the name of W.T. Wynn and not his 18 estate, and so that is -- you know, even if they could 19 find some relatives there would have to be a probate, 20 21 which could take a while to prove up. 22 And Mr. Wynn does not own any working interest. He has zero net revenue interest in this well. 23 24 EXAMINER McCLURE: Okay. I was going to say, 25 yeah, if you just wanted to supplement us with just a

Page 5 1 brief summary of what effort was taken. 2 MR. BRUCE: I will. 3 EXAMINER McCLURE: That would be the only 4 additional thing I would be looking at for this case. 5 No other questions. Thank you. 6 MR. BRUCE: Thank you. EXAMINER BRANCARD: Thank you. I had similar 7 questions. How do you know he's dead? I assume somebody 8 must have figured that out somehow. 9 MR. BRUCE: Uhm, I think the BLM knew through 10 itself, just because -- and I did not go look at the BLM 11 12 lease file or check out the date of this lease, but this is a rather old federal lease. Any lease beginning with 13 the number zero tends to be decades and decades old, and 14 15 his W-10 (phonetic), for instance if he was the lessee of 16 record in 1950, I'm thinking it's reasonable. 17 And I can check on that with respect to the other info I'm going to provide the Division. 18 19 EXAMINER BRANCARD: So just educate me here, then, Mr. Bruce. 20 21 A record title owner, that means he's the 22 name on the lease but somebody else has the working -- he 23 farmed out his interest? Or did at some point. 24 MR. BRUCE: Yeah, at some point. He was the 25 original lessee but he assigned out here and there various

Page 6 operating rights to the point where at least in the Bone 1 2 Spring Formation he owns no leasehold rights other than 3 what is called bare record title. 4 EXAMINER BRANCARD: So even though he has no interest really, BLM is not willing to clean up its own 5 records, they just want us to --6 7 MR. BRUCE: That's pretty much it. EXAMINER BRANCARD: -- have a hearing and make 8 sure nobody shows up. 9 MR. BRUCE: Yeah. 10 11 EXAMINER BRANCARD: Okay. All right. Are there 12 any other interested persons in Case 22245? (Note: 13 Pause.) Hearing none, we will admit the exhibits 14 15 into the record. If you could provide just a little more 16 clarification about what you-all know about Mr. Wynn, that 17 would be helpful. And other than we will continue this case to December 2nd to run the clock on the Notice, and 18 hopefully that will be it. 19 20 MR. BRUCE: Thank you. 21 (Time noted 10:10 a.m.) 22 23 24 25
