- EXAMINER BRANCARD: With that I call Case 22273,
- 3 Mewbourne Oil Company.
- 4 MR. BRUCE: Mr. Examiner, Jim Bruce one more
- 5 time.
- 6 EXAMINER BRANCARD: All right.
- 7 And then MRC Permian.
- 8 MR. FELDEWERT: May it please the Examiner,
- 9 Michael Feldewert with the Santa Fe office of Holland &
- 10 Hart appearing on behalf of MRC. We do not object to the
- 11 matter proceeding by affidavit.
- 12 EXAMINER BRANCARD: Thank you.
- 13 Are there any other persons interested in
- 14 Case 22273? (Note: Pause.) Hearing none, Mr. Bruce you
- 15 may proceed.
- 16 MR. BRUCE: Yes, Mr. Examiner. In this case
- 17 Mewbourne seeks to force pool the Wolfcamp Formation
- 18 underlying the south half of Section 24 and the south half
- 19 of Section 23, 20 South, 28 East.
- 20 The Application and Proposed Ad are
- 21 included. There's a Verified Statement of the landman
- 22 setting forth interest ownership, and C-102s.
- This is not -- it's a 320-acre spacing in
- 24 this pool but it's not the Purple Sage, it's the Burton
- 25 Flat North Wolfcamp Gas, Which is based on 320 under the

- 1 old pool rules, or the old OCD rules.
- 2 There is a Statement of Interest; the
- 3 parties being pooled; the summary of communications with
- 4 all the parties. Everybody has pretty much been
- 5 contacted, although when it came to Notice on that, the...
- 6 And the AFEs for the wells are also
- 7 attached.
- 8 The landman's affidavit, by Charlie Crosby
- 9 again, contains the Structure Map, Isopach, Cross Section
- 10 showing the continuity of the reservoir across the well
- 11 unit and across the area developed. The reservoir is
- 12 horizontal drilling.
- I sent out Certified Mail, and although I
- 14 do have an Affidavit of Publication, all the parties did
- 15 receive actual Notice via Certified Mail, so all parties
- 16 were properly notified.
- 17 Exhibit 6 is the Pooling Checklist, which I
- 18 think is in order.
- 19 And I would move the admission of Exhibits
- 20 1 through 6 and ask that the matter be taken under
- 21 advisement.
- 22 EXAMINER BRANCARD: Thank you.
- 23 Mr. Bruce, I'm looking at our case file and
- 24 I don't see your exhibits.
- 25 MR. BRUCE: I did send them in. I guess

- 1 that's -- (Note: Pause.) I believe I sent these in on
- 2 Tuesday, so I don't know what happened, unless I hit the
- 3 wrong button somewhere along the line.
- 4 EXAMINER BRANCARD: May be sitting in some other
- 5 case file.
- 6 MR. BRUCE: Well, I can certainly resubmit them.
- 7 This was one where I had mistakes in some
- 8 of the Notice materials, so this was originally filed
- 9 under Case 22159, and I dismissed that Application and
- 10 refiled. You can see the same basic exhibits except for
- 11 the Notice ones in Case 22159.
- But I did submit these. I just don't know
- 13 what happened. I'll check that out and, if necessary,
- 14 I'll resubmit. And if the case has to be continued, so be
- 15 it, but at least my Notice was complete.
- 16 EXAMINER BRANCARD: Mr. McClure, do you have any
- 17 questions?
- 18 MR. BRUCE: I'll go ahead and refile them right
- 19 now, but if it needs to be continued, so be it.
- 20 EXAMINER McCLURE: I don't have any questions.
- 21 Thank you.
- 22 EXAMINER BRANCARD: Mr. McClure, I assume you
- 23 haven't seen the exhibits either. Is that correct?
- 24 EXAMINER McCLURE: Yes, that's also correct. I
- 25 was trying to do a quick search, but I didn't get a chance

- 1 to yet.
- But, regardless, the fact I have no
- 3 questions is based purely on testimony. I have not seen
- 4 the exhibits.
- 5 EXAMINER BRANCARD: Would you like some time to
- 6 look at the exhibits?
- 7 MR. BRUCE: Let me send them right now.
- 8 EXAMINER McCLURE: I was going to say, I mean
- 9 obviously before we were to issue an Order on it, we will
- 10 obviously have to see it. As to whether we need to come
- 11 back to hearing, maybe we could just -- I don't know what
- 12 your thought process is there.
- MR. BRUCE: How quickly do they get into the
- 14 file once I send them through the portal?
- 15 EXAMINER BRANCARD: Pretty quickly. Marlene has
- 16 to --
- 17 MS. SALVIDREZ: This is Marlene. And I do
- 18 approve them right away. So as soon as you hit "Submit" I
- 19 should see it on my side.
- MR. BRUCE: Okay.
- MS. SALVIDREZ: So I'm here right now, so if you
- 22 could do it right away, it would be great.
- MR. BRUCE: Why don't we move on to the next
- 24 case, and then we can come back to mine a little down the
- 25 road.

- 1 EXAMINER BRANCARD: Okay.
- 2 So are there any other interested persons,
- 3 then, in -- and I forgot to ask Mr. Feldewert if he had
- 4 any questions.
- 5 MR. FELDEWERT: I do not. Thank you, Mr.
- 6 Examiner.
- 7 EXAMINER BRANCARD: Any other interested persons
- 8 in Case 22273? (Note: Pause.)
- 9 Hearing none, we will admit the exhibits
- 10 when we get them, and I think if we have any issues we
- 11 will let you know, Mr. Bruce. Otherwise, the case is
- 12 taken under advisement.
- MR. BRUCE: Thank you.
- 14 EXAMINER McCLURE: Mr. Brancard, it does look
- 15 like there is a draft on file, but it hasn't been
- 16 officially submitted to us, so I don't know that we could
- 17 actually accept it or not. But it does look like there
- 18 was a draft made on 11-2.
- 19 EXAMINER BRANCARD: I have no idea what you're
- 20 looking at, Mr. McClure.
- 21 EXAMINER McCLURE: Essentially it's on their
- 22 side, what they make, and then once they hit "Submit" then
- 23 we see it on our side. But we can't accept it into the
- 24 record even if we wanted to.
- 25 It's like when they start something it's in

- 1 draft status.
- 2 EXAMINER BRANCARD: I see.
- 3 EXAMINER McCLURE: If they don't actually hit
- 4 the Submit button that's where it's at.
- 5 EXAMINER BRANCARD: Sounds like Mr. Bruce needs
- 6 to hit a button.
- 7 EXAMINER McCLURE: Yes, that's what it seems.
- 8 EXAMINER BRANCARD: Thank you.
- 9 (Time noted 10:17 a.m.)
- 10 (Note: Other cases heard.)
- 11 (Time noted 11:19 a.m.)
- MR. BRUCE: Mr. Examiner, about an hour ago I
- 13 did refile -- or file, I suppose -- the exhibits in Case
- 14 22273, so they are available to you folks.
- 15 EXAMINER BRANCARD: All right. Mr. McClure, you
- 16 can look at those exhibits while we are dealing with the
- 17 next case.
- 18 EXAMINER McCLURE: While the lawyers talk.
- 19 (Note: Other cases were heard.)
- 20 (Time noted 11:58 a.m.)
- 21 EXAMINER BRANCARD: Thank you.
- 22 And finally, Mr. McClure, have you had a
- 23 chance to look at the exhibits?
- 24 EXAMINER McCLURE: Yes, sir, I did. I skimmed
- 25 through them.

I guess I just had a quick follow-up

- 2 question if Mr. Bruce is still on.
- 3 EXAMINER BRANCARD: Mr. Bruce, I think we are
- 4 back on 22273, if you're there.
- 5 Mr. Bruce, are you there?
- 6 EXAMINER McCLURE: Actually, I don't see him
- 7 there.
- 8 EXAMINER BRANCARD: Do we have any more Call-In
- 9 Users, Ms. Salvidrez?
- 10 MS. SALVIDREZ: There is a Call-In User 3, but I
- 11 think he came in as another caller, so I don't think he's
- 12 on.
- 13 EXAMINER BRANCARD: All right. Well, it is
- 14 noon.
- 15 EXAMINER McCLURE: I was going to say
- 16 essentially what my question was, was in regards to
- 17 Notice. I didn't recall whether he stated all Notice
- 18 looked good. It looks like they have signatures on all
- 19 their green cards other than one, but USPS looks like it
- 20 was delivered. I just wanted to confirm that, because it
- 21 looks like Public Notice was made on the 23rd.
- 22 EXAMINER BRANCARD: I think he confirmed that
- 23 all Notice was provided directly to the parties. That was
- 24 his argument in that case. If that's not true then we
- 25 have a problem.

1 EXAMINER McCLURE: It looks like it. I was just

- 2 going to confirm that.
- 3 EXAMINER BRANCARD: Let's indicate that he
- 4 stated that there was actual Notice of the interested
- 5 parties in this case so therefore the publication was just
- 6 icing.
- 7 EXAMINER McCLURE: Okay. Okay. That was my
- 8 main question, because it looked like the Public Notice
- 9 was further than the 10 business days was all. But, yeah,
- 10 okay, sounds good.
- I have no other questions, or no questions
- 12 at all at this juncture, then.
- 13 EXAMINER BRANCARD: All right. With that, Case
- 14 22273 will be taken under advisement and the exhibits that
- 15 we finally have will be admitted into the record.
