- 3 MS. LUCK: Good morning, Mr. Examiner, Kaitlyn
- 4 Luck with the Santa Fe office of Holland & Hart for the
- 5 applicant in these two cases, Novo Oil and Gas Northern
- 6 Delaware LLC.
- 7 HEARING EXAMINER BRANCARD: Thank you. Are there
- 8 any other interested persons for Cases 22350, 22351?
- 9 (No audible response.)
- 10 HEARING EXAMINER BRANCARD: Hearing none, Ms.
- 11 Luck, you may proceed.
- 12 MS. LUCK: Thank you. Novo understood there
- would be no opposition to these cases proceeding by
- 14 affidavit today, and so on Tuesday Novo filed its exhibit
- 15 package which included as Exhibit A copies of Novo's
- 16 application in both cases.
- 17 As reflected in the application, Novo seeks to
- 18 amend the existing orders. The order numbers are R-21092
- 19 and 21092-A, and that's in the first case, 22350.
- 20 And then in the second case, 22351, Novo seeks to
- 21 amend Order Numbers R-21093 and 21093-A. And the requested
- 22 extension for both of these cases is an extension of the
- 23 drilling deadline.
- In both cases the drilling deadline for the
- 25 initial well is December 24, 2021, and so Novo submitted the

1 affidavit of Brandon Patrick in Exhibit D and that reflects

- 2 that Novo is seeking the drilling extensions because at the
- 3 time these applications were submitted, Novo had not yet
- 4 received approval of its drilling permits from the BLM.
- 5 But since these applications were filed, the BLM
- 6 also approved the permits, so Novo has started on the
- 7 drilling pads, but to ensure that Novo has sufficient time
- 8 to complete the drilling pads and all the initial
- 9 preparation that are required to get started drilling, Novo
- 10 would still request the drilling extension through December
- 11 24 of 2022, and that applies for both cases as is claimed in
- 12 Novo exhibits.
- 13 And then as required by the Division rules, Novo
- 14 provided notice of these drilling extensions to these
- 15 working interest owners, and that's reflected in Novo's
- 16 Exhibit C, and Novo's Exhibit C also reflects that notice of
- 17 this hearing was published as well in the Carlsbad Current
- 18 Argus.
- 19 So with that I would move the admission of Novo's
- 20 Exhibit A through D and request that the cases be taken
- 21 under advisement if there aren't any questions.
- 22 HEARING EXAMINER BRANCARD: Thank you. Mr.
- 23 Rose-Coss, any questions?
- 24 TECHNICAL EXAMINER ROSE-COSS: No questions.
