1 HEARING EXAMINER BRANCARD: All right. We will

- 2 call our first hearing for today, Items 31 and 32 on the
- 3 worksheet, Cases 22263, 22264, Cimarex Energy Company.
- 4 MS. BENNETT: Good morning, Mr. Examiner. Deana
- 5 Bennett on behalf of Cimarex Energy Company.
- 6 HEARING EXAMINER BRANCARD: And I see EOG
- 7 Resources has entered an appearance.
- 8 MR. RITTENHOUSE: Yes, sir. This is Joby
- 9 Rittenhouse from Beatty & Wozniak appearing on behalf of
- 10 EOG.
- 11 HEARING EXAMINER BRANCARD: Thank you. Are there
- 12 any other entries of appearance for Cases 22263, 22264?
- 13 (No audible response.)
- 14 HEARING EXAMINER BRANCARD: Hearing none, Ms.
- 15 Bennett, you may proceed.
- 16 MS. BENNETT: Thank you very much, Mr. Examiner.
- 17 EOG did enter an appearance in these cases before they were
- 18 set for the original hearing, and we continued the cases
- 19 before the original hearing, and now they were set for
- 20 today's date, and I haven't heard any objection from EOG to
- 21 present those cases by affidavit, so that's my intention
- 22 today.
- HEARING EXAMINER BRANCARD: Mr. Rittenhouse?
- MR. RITTENHOUSE: No objection. Please continue.
- MS. BENNETT: Thank you. Thank you. So in these

- 1 two cases Cimarex is seeking an extension of time to
- 2 commence drilling under the orders, and in both cases, I
- 3 submitted exhibits in both cases that are essentially
- 4 identical.
- 5 The first exhibit in the case packet is the
- 6 declaration of Riley Morris. He is the land professional
- 7 for Cimarex Energy Company, and he has been -- he has
- 8 testified before the Division and his credentials have been
- 9 accepted as a matter of record.
- 10 And in his declaration he describes the reasons
- 11 for needing the extension of time, which are due to the
- 12 disruptions in the market and Covid and the disruption in
- 13 drilling schedules that hopefully are coming to an end, but
- 14 these orders are also coming to an end, so that's the reason
- 15 why Cimarex is seeking a one-year extension of time for
- 16 these two orders.
- 17 And the two orders are in Case Number 22263, it's
- 18 Order R-21324. And in case Number 22264, it's Order Number
- 19 R-21325. And as I mentioned, in each case Cimarex is
- 20 seeking a one year extension of time to commence drilling.
- 21 Behind Mr. Morris's declaration, I have included
- 22 our application, the two orders that we are seeking to be
- 23 amended and the notice affidavit showing that notice of
- 24 today's hearing was timely provided, and also affidavit of
- 25 publication. And in both cases, Cimarex is seeking an

- 1 extension of time from March 15, 2022 to March 15, 2023.
- 2 And so with that, I would ask that the exhibits
- 3 in Case Numbers 22263 and 22264 be accepted into the record
- 4 and that these cases be taken under advisement. Thank you.
- 5 HEARING EXAMINER BRANCARD: Mr. Rittenhouse, any
- 6 questions or comments?
- 7 MR. RITTENHOUSE: No, sir, thank you.
- 8 HEARING EXAMINER BRANCARD: Ms. Murphy, any
- 9 questions.
- 10 TECHNICAL EXAMINER MURPHY: I do not have any
- 11 questions, thank you.
- 12 HEARING EXAMINER BRANCARD: All right. This is
- 13 the second extension, Ms. Bennett.
- MS. BENNETT: That's correct.
- 15 HEARING EXAMINER BRANCARD: And the logic is
- 16 problems with scheduling for Covid?
- 17 MS. BENNETT: Yes, yes, that's right. Mr. Morris
- 18 explains in his affidavit or in his declaration that the
- 19 first extension of time was, you know, due to Covid, but
- 20 there's been continuing delays as a result of Covid that has
- 21 caused further postponement of drilling plans and drilling
- 22 schedules, so that's the reason for the second extension of
- 23 time.
- 24 HEARING EXAMINER BRANCARD: Thank you. I quess
- 25 we will start looking at these really carefully when the
