- 3 morning, everybody. It is February 22, 2022. It is
- 4 9:11 a.m., and this is a regularly scheduled meeting of
- 5 the Oil Conservation Commission.
- I am Adrienne Sandoval, Chair of the Oil
- 7 Conservation Commission and head of the Oil Conservation
- 8 Division.
- 9 Also with me today are the two other
- 10 commissioners. Would you please introduce yourselves for
- 11 the record.
- 12 COMMISSIONER BLOOM: Sure. Good morning. Thank
- 13 you.
- 14 Madam Chair, my name is Greg Bloom. I am
- 15 the Designee of the Commissioner of Public Lands,
- 16 Stephanie Garcia-Richard. Thanks.
- 17 COMMISSIONER AMPOMAH: Thank you, Madam Chair.
- 18 Good morning, everyone. I am Dr. William
- 19 Ampomah, Designee of the Energy Secretary and also a
- 20 professor at New Mexico Tech. Thank you.
- 21 COMMISSION CHAIR SANDOVAL: Also with us today
- 22 is Chris Moander, counsel for the Commission, and Florene
- 23 Davidson, Clerk to the Commission.
- 24 First item on the agenda is Approval of the
- 25 Agenda.

1 The agenda will move forward as written.

- 2 Is there a Motion for Approval of the Agenda?
- 3 COMMISSIONER BLOOM: Madam Chair, I move to
- 4 approve the agenda.
- 5 COMMISSION CHAIR SANDOVAL: Second.
- 6 COMMISSIONER AMPOMAH: Madam Chair, I do second.
- 7 COMMISSION CHAIR SANDOVAL: Mr. Moander, would
- 8 you do roll call, please.
- 9 MS. MOANDER: Yes, Madam Chair.
- 10 Commissioner Ampomah.
- 11 COMMISSIONER AMPOMAH: Approved.
- 12 MR. MOANDER: Commission Bloom.
- 13 COMMISSIONER BLOOM: Approved.
- MR. MOANDER: Madam Chair.
- 15 COMMISSION CHAIR SANDOVAL: Approved.
- MR. MOANDER: The motion carries.
- 17 COMMISSION CHAIR SANDOVAL: The next item is
- 18 approval of the January 13th and 14th 2022 commission
- 19 meeting minutes.
- 20 Commissioners, is there a motion to approve
- 21 those meeting minutes?
- 22 COMMISSIONER BLOOM: Madam Chair, I would move
- 23 to approve the minutes from our January meeting.
- 24 COMMISSION CHAIR SANDOVAL: Is there a second?
- 25 COMMISSIONER AMPOMAH: Madam Chair, I second.

1 COMMISSION CHAIR SANDOVAL: Mr. Moander, would

- 2 you do a roll call, please.
- 3 MR. MOANDER: Yes, Madam Chair.
- 4 Commissioner Ampomah.
- 5 COMMISSIONER AMPOMAH: Approve.
- 6 MR. MOANDER: Commissioner Bloom.
- 7 COMMISSIONER BLOOM: Approved.
- 8 MR. MOANDER: Madam Chair?
- 9 COMMISSION CHAIR SANDOVAL: Approved.
- 10 MR. MOANDER: The motion carries.
- 11 COMMISSION CHAIR SANDOVAL: Thank you. All
- 12 right. Next item on the agenda is continuance of Case No.
- 13 21324, but before we jump into that I just want to do a
- 14 little housekeeping.
- 15 So we still need to do deliberations and
- 16 voting on 21324. I'm expecting that's going to take a
- 17 little bit of time. Following that, we have Agenda Item
- 18 No. 5, which is De Novo Case No. 21744. So that the
- 19 lawyers aren't just sitting here, my recommendation would
- 20 be for counsel in that case to check back in around 10:30.
- 21 And, you know, we may still be deliberating or going on
- 22 Agenda Item No. 4, but I think it will take likely at
- 23 least that much time, and we won't start on that case
- 24 until at least 10:30 if we were to finish earlier.
- 25 Does that work for counsel in Case No.

- 2 MR. PADILLA: It does for me. This is Ernest
- 3 Padilla.
- 4 MR. SAVAGE: Madam Chair, this should work as
- 5 well.
- 6 COMMISSION CHAIR SANDOVAL: Okay. Sorry, Mr.
- 7 Rankin.
- 8 MR. RANKIN: It's okay. I'm here, too. I'm
- 9 just going to be monitoring the case but that works for me
- 10 as well. No problem.
- 11 COMMISSION CHAIR SANDOVAL: Okay. Well, then
- 12 YOU guys are welcome to either hop off and rejoin, or just
- 13 stick on and stay on mute. And I would check back in at
- 14 10:30, but we would not start Case No. 21744 until at
- 15 least 10:30.

- 20 MR. MOANDER: Excellent. And with that, I would
- 21 recommend we go ahead and proceed through the remainder of

- 24 COMMISSIONER CHAIR SANDOVAL: Okay. I mean the
- 25 remainder of the agenda is Other Business, so if the

- 1 witnesses need to drop, you can drop.
- MR. MOANDER: They don't need to stay.
- 3 COMMISSIONER CHAIR SANDOVAL: Okay. Let's see.
- 4 Agenda Item No. 6, since we are continuing Agenda Item
- 5 No. 5 onto the regularly scheduled March 10th the docket.
- 6 Mr. Moander, do you have any updates on any
- 7 litigation?
- 8 MR. MOANDER: I mean, I do to the extent that
- 9 there's -- it's Case A-1-CA-39578, which I have updated
- 10 the Commission several times about.
- I checked the docket. I haven't received
- 12 any additional pleadings or Notices, and so we are still
- 13 awaiting a ruling from the Court of Appeals on that case.
- 14 COMMISSIONER CHAIR SANDOVAL: Thank you.
- 15 Any other business before the Commission
- 16 today?
- 17 COMMISSIONER BLOOM: Madam Chair, it sounds like
- 18 on our March meeting here, really the focus is going to be
- 19 finishing up Cimarex and Colgate on the 10th. I'd let you
- 20 know, but if we need more time, or if you see any other
- 21 need for time, I'd be available that Friday morning, the
- 22 11th, and I'm going to be out the next two weeks. It's
- 23 like my first vacation in three years, so I won't be
- 24 available at all. I'm taking my I-phone, and I'm going --
- MR. MOANDER: How dare you.
