- 6 HEARING EXAMINER BRANCARD: Thank you. Colgate
- 7 Operating?
- 8 MS. HARDY: Dana Hardy with Hinkle Shanor on
- 9 behalf of Colgate Operating.
- 10 HEARING EXAMINER BRANCARD: Thank you. Any other
- 11 interested persons for Cases 22577, 22578?
- 12 (No audible response.)
- 13 HEARING EXAMINER BRANCARD: Hearing none, Mr.
- 14 Savage, it's yours.
- 15 MR. SAVAGE: Thank you. In these cases Cimarex
- 16 seeks to cure personal service by letter to Colgate. In
- 17 Case 22577, Cimarex seeks to reopen Case 22145 and address
- 18 Orders Number R-21892 which establishes the standard 320
- 19 acre more or less spacing unit comprised of the N/2 S/2 of
- 20 Section 16 and 17, and pooled -- and pooling all
- 21 uncommitted interests underlying the unit in the Bone Spring
- 22 formation now dedicated to Parkway 16-17 3H well. In
- 23 case -- and let me get you the township range for those.
- 24 That's Township 19 South, Range 29 East, Eddy County.
- In Case Number 22578, Cimarex seeks to reopen

1 Case 22146 and address Order RR-21893 which established a

- 2 standard 160 acre, more or less, spacing unit comprised of
- 3 the S/2 S/2 of Section 16 and pool all uncommitted interests
- 4 underlying the unit in the Bone Spring Formation now
- 5 dedicated to the Parkway 16 State Com 4H Well within the
- 6 same township, range.
- 7 In Exhibit A, Tab 2, landman Mr. Riley Morris,
- 8 who is familiar with the subject lands and who has
- 9 credentials that have been accepted by the Division as an
- 10 expert witness testifies that Cimarex is in good standing,
- 11 under the existing pooling orders. It has done a diligent
- 12 search of its mailing lists for the unit and discovered that
- 13 Colgate did not receive personal services.
- 14 However, Colgate was listed in the breakdown of
- 15 ownership exhibits used in the pooling cases as an
- 16 uncommitted working interest owner and was pooled with the
- 17 other owners listed.
- 18 Furthermore, the chronology of contact exhibits
- 19 in the cases show that Cimarex made good-faith attempts to
- 20 reach voluntary agreement with Colgate prior to the hearing.
- 21 Cimarex's only oversight was not sending the notice letter
- 22 because its mailing list inadvertently had not been updated.
- 23 Mr. Morris seeks reopening the cases to
- 24 effectuate letter notice and provide Colgate the opportunity
- 25 to make an appearance which it done and address any

- 1 concerns.
- 2 Exhibit B is a hearing packet, contains a copy of
- 3 the notice letter which shows the personal service by letter
- 4 to Colgate was sent and received, and in this case also
- 5 needs to be amended to show the status of the mailing.
- 6 We respectfully ask the Division to note these
- 7 facts and amend Orders R-21892 and R-21893 that pool the
- 8 interests in the unit and designate Cimarex as the operator.
- 9 We request Exhibits A and B for these two cases
- 10 and related sub exhibits be admitted into the record and
- 11 that Cimarex's application be taken under advisement.
- 12 HEARING EXAMINER BRANCARD: Thank you. Any
- 13 questions or objections from Colgate?
- 14 MS. HARDY: No questions or objections. Thank
- 15 you.
- 16 HEARING EXAMINER BRANCARD: Mr. McClure.
- 17 TECHNICAL EXAMINER McCLURE: I don't have any
- 18 questions on these two cases either. The only thing I might
- 19 add, though, is the current status of the packet that was
- 20 sent to Colgate looks like it was the same packet for all
- 21 four of these cases. The current reported status is in
- 22 transit to next facility as of February 16, 2022.
- 23 MR. SAVAGE: Okay. We will -- thank you, Mr.
- 24 McClure. We will update those and make sure the Division
- 25 and Ms. Hardy receives copies.
