1 HEARING EXAMINER BRANCARD: With that, we have

- 2 Case 22580, Mewbourne Oil Company.
- 3 MR. BRUCE: Mr. Examiner, Jim Bruce on behalf of
- 4 Mewbourne.
- 5 HEARING EXAMINER BRANCARD: Any there any other
- 6 interested persons for Case 22580?
- 7 (No audible response.)
- 8 HEARING EXAMINER BRANCARD: Hearing none, please
- 9 proceed, Mr. Bruce.
- 10 MR. BRUCE: In this case, Mr. Examiner, Mewbourne
- 11 seeks pooling of the Wolfcamp formation underlying the S/2
- of Section 13 and the S/2 of Section 14, 23 South, 26 East
- in the Purple Sage Wolfcamp Gas Pool for purposes of
- 14 drilling its Airboss Wolfcamp Wells. The only party sought
- 15 to be pooled is WPX Energy Permian LLC, affidavit of the
- 16 landman or self-affirmed statement of the landman is
- 17 attached with the usual land plats, C-102s, a listing of
- 18 contacts with WPX and the proposal letter and AFEs.
- 19 The geologist affidavit contains the usual
- 20 information on the structure, cross section, and they also
- 21 give information on production from Wolfcamp wells in the
- 22 area. And if you look at some of these wells, they are
- 23 quite good wells.
- The preferred orientation in this area, I think
- 25 as in most of the Purple Sage Wolfcamp, there are both

1 horizontal and vertical wellbores that are good, so it

- 2 really doesn't matter much.
- 3 Exhibit 4 is my affidavit of notice, and that is
- 4 where the problem comes in. And so I would -- once again, I
- 5 will comply with what the Division requires. I sent notice
- 6 to WPX Permian and I have attached the -- I did not
- 7 received the green card back. I did attach the white card
- 8 to a list of the operators listed in the Division's records
- 9 showing that notice was mailed to WPX at its operator's
- 10 approved address.
- I have not gotten the green card back, as I said,
- 12 and when you go onto the USPS website as of a dozen or more
- 13 days ago it says the letter is out for delivery. If the
- 14 Division would like me to remail notice or do whatever
- 15 necessary to cure this, I have no objection.
- 16 I just don't know why I'm not getting -- I only
- 17 used to have this problem with EOG, and -- but this is the
- 18 second time I haven't been able to get an address back or a
- 19 green card back from WPX Energy, so I will leave that to the
- 20 Division. I will comply with whatever requirement the
- 21 Division needs.
- 22 HEARING EXAMINER BRANCARD: Mr. McClure, any
- 23 questions?
- 24 TECHNICAL EXAMINER McCLURE: No, sir, I have no
- 25 questions on this case.

1 HEARING EXAMINER BRANCARD: Mr. Bruce, this is a

- 2 question that relates to this case and the next case. The
- 3 document you have that comes right after your C-102, this is
- 4 a (inaudible) I don't know what you have in front of it. It
- 5 lists, it lists several other interest owners in these
- 6 tracts.
- 7 MR. BRUCE: Oh, Mewbourne has come to terms with
- 8 those interest owners.
- 9 HEARING EXAMINER BRANCARD: Okay.
- 10 MR. BRUCE: And I would simply request to notify
- 11 only WPX because the other parties have committed their
- 12 interests to the well -- wells.
- 13 HEARING EXAMINER BRANCARD: Okay. I guess what
- 14 we can do here is just take this case under advisement and
- 15 you can provide us with some updated information from the
- 16 postal system.
- 17 MR. BRUCE: I will do that. I will do that. I
- 18 think I heard one other attorney saying something earlier
- 19 that USPS online service just said it's out for delivery and
- 20 you are just kind of in wonderland there.
- 21 HEARING EXAMINER BRANCARD: Are there any other
- 22 interested persons -- I think we are on Case 22580.
- 23 (No audible response.)
- 24 HEARING EXAMINER BRANCARD: Hearing none, the
