1 HEARING EXAMINER BRANCARD: With that I will call

- 2 Cases 22568 and 22569, Colgate Operating.
- 3 MS. McLEAN: Good morning, Mr. Examiner, Jaclyn
- 4 McLean on behalf of Colgate Operating.
- 5 HEARING EXAMINER BRANCARD: Thank you. Are there
- 6 any other entries of appearance for Cases 22568 and 22569?
- 7 (No audible response.)
- 8 HEARING EXAMINER BRANCARD: Hearing none, Ms.
- 9 McLean, you may proceed.
- 10 MS. McLEAN: Thank you. In Case Numbers 22569
- 11 and 22568, Colgate seeks to pool additional interests under
- 12 Order Number R-21439 and R-21438. On August 24, 2020, the
- 13 Division entered Order Number R-21438 in Case Number 21078
- 14 which pooled all uncommitted interests in the Winchester
- 15 Bone Spring Pool within the Bone Spring Formation in 320
- 16 acre standard horizontal spacing unit comprised of the N/2
- 17 S/2 of Section 27, in N/2 S/2 of Section 28, Township 19
- 18 South, Range 28 East in Eddy County and dedicated the unit
- 19 to the Big Burro 27 State Com 123H and 133H wells.
- 20 And in Order R-21439, Case 21079, the Division
- 21 pooled all uncommitted interests in the Winchester Bone
- 22 Spring Pool within the Bone Spring Formation in a 320 acre
- 23 standard horizontal spacing unit, comprised of the S/2 S/2
- of Section 27 and the S/2 S/2 of Section 28, Township 19
- 25 South, Range 28 East, and dedicated that to the Big Burro 27

1 State Com 124H and 134H Wells, and both orders designated

- 2 Colgate as the operator of the unit and the wells.
- 3 After the entry of those orders, Colgate
- 4 identified one unlocatable working interest owner whose
- 5 interest should be pooled under Order Number R-21439 and
- 6 R-21438. And this one unlocatable working interest owner is
- 7 the SB Association.
- Now, prior to the hearing in this matter, in
- 9 October to December 2019, Colgate has sent multiple letters
- 10 to SB Association and the mailing went unclaimed. Then
- 11 Colgate attempted to resend the well proposal letters to a
- 12 possible alternate address which also went unclaimed.
- Colgate's landman, Mark Hadjik, also attempted to
- 14 find addresses for SB Association on the internet,
- 15 (inaudible) website and attempted to identify original
- 16 principals of the entity without any luck.
- 17 And this is all set out in Mr. Hadjik's self-
- 18 affirmed statement, which is Exhibit A. And Exhibit 5 to
- 19 Exhibit A is the chronology of communications which details
- 20 all of this effort to find SB Association.
- 21 Then to complicate matters, prior to and after
- 22 the August 18, 2020 period in Case 21078 and 21079, there
- 23 was a title discrepancy where WPX claims SB Association's
- 24 interest. An updated title was received after the issuance
- 25 of the order, and it was determined that WPX did not

- 1 actually acquire SB Association's interest, so SB
- 2 Association does need to be added to the pooling order.
- 3 The exhibit packet submitted to the Division for
- 4 Case Number 22568 and 22569 contains Exhibit A, which is the
- 5 land professional's testimony and related exhibits which
- 6 include the orders that Colgate is seeking to reopen, a plat
- 7 of tract of ownership of the additional interest to be
- 8 pooled under the terms of R-21439 and R-21438, as well as
- 9 the well proposal letter to SB Association and a summary of
- 10 communications as I mentioned earlier.
- 11 And Exhibit B is a notice affidavit from our
- 12 office which sets out when the notice letter of this hearing
- 13 and application were sent to the last known address of SB
- 14 Association, and additional Exhibit B-3 is the affidavit of
- 15 publication which showed that notice was published to SB
- 16 Association in the Carlsbad newspaper on March 15, 2022.
- 17 And with that, I ask that Exhibits A and B be
- 18 admitted into the record in Case Numbers 22569 and 22568 and
- 19 that these cases be taken under advisement.
- 20 HEARING EXAMINER BRANCARD: Thank you. Mr.
- 21 Rose-Coss, any questions?
- 22 TECHNICAL EXAMINER ROSE-COSS: No. I had some
- 23 questions before that explanation of what was going on in
- 24 the case, and after that I don't have any more questions, so
- 25 everything was resolved for me.

- 1 MS. McLEAN: Thank you. Thank you.
- 2 HEARING EXAMINER BRANCARD: Thank you. And
- 3 appreciate the explanation and the efforts by your land
- 4 person to try to track down this party. That's what we like
- 5 to see.

- 7 HEARING EXAMINER BRANCARD: Thank you, and so
- 8 that's the entire extent of the amendment is to add this
- 9 party; is that correct?
- 10 MS. McLEAN: That's correct.
- 11 HEARING EXAMINER BRANCARD: With that, the
- 12 exhibits -- are there any other persons with an entry of
- 13 appearance in Case 22568 and 22569?
- 14 (No audible response.)
- 15 HEARING EXAMINER BRANCARD: Hearing none, Cases
