2 skip forward then to Item 22. This is Case 22660, Titus Oil
3 & Gas.

4 MS. SHAHEEN: Good morning, Mr. Examiner. Sharon
5 Shaheen on behalf of Titus Oil & Gas.

6 HEARING EXAMINER BRANCARD: Are there any other
7 entries of appearance for Case 22660?

8 (No audible response.)

9 HEARING EXAMINER BRANCARD: Hearing none, Ms.
10 Shaheen, you may proceed.

11 MS. SHAHEEN: Thank you. This case was continued
12 because my paralegal inadvertently omitted filing the
13 exhibit package on April 3, and the Division alerted me to
14 that on April 5. We submitted the exhibit package that day,
15 April 5, and I'm hoping that it is satisfactory to the
16 hearing examiner and that this case will now be taken under
17 advisement.

18 HEARING EXAMINER BRANCARD: All right. Did you
19 present the case?

20 MS. SHAHEEN: I did. And after the case was
21 presented, it was noted that --

22 HEARING EXAMINER BRANCARD: Okay, all right. So
23 this is a continuation. Mr. Rose-Coss, any questions in
24 Case 22260?

25 TECHNICAL EXAMINER ROSE-COSS: Case 22260?

1 HEARING EXAMINER BRANCARD: Yes, Titus Oil & Gas.

2 TECHNICAL EXAMINER ROSE-COSS: This is the case
3 that was for an extension of time in which to commence the
4 drilling initially. Is that what was presented on an
5 earlier date?

6 MS. SHAHEEN: I believe the case is 22660.

7 TECHNICAL EXAMINER ROSE-COSS: 22260, yes. My
8 only comment going forward on those, I don't work compulsory
9 pooling as much, I'm more in the salt water disposal realm,
10 and for second extensions of time, the second year that the
11 extension has gone on, in that realm we are asking for an
12 actual plan of development to complete the project within
13 the year.

14 So in this case, but as a kind of (inaudible)
15 something like that might be required for cases like this in
16 the future when you come to hearing. Other than that, no
17 questions, and I suppose this has already kind of
18 administratively been accepted, the official documentation.

19 MS. SHAHEEN: Thank you for that information.

20 TECHNICAL EXAMINER ROSE-COSS: Thank you.

21 HEARING EXAMINER BRANCARD: Thank you. Hearing
22 no other concerns, Case 22660 will be taken under
23 advisement. Thank you.
