- 2 EXAMINER BRANCARD: So let's move forward. I'm
- 3 on Item No. 22, Cases 22663, 22664, 22665, Matador
- 4 Production Company.
- 5 MR. BRUCE: Mr. Examiner, Jim Bruce
- 6 representing Matador.
- 7 EXAMINER BRANCARD: Tony La Russa wells.
- 8 Tap Rock, LLC.
- 9 MS. SHAHEEN: Good morning. Sharon Shaheen on
- 10 behalf of Tap Rock, LLC.
- 11 EXAMINER BRANCARD: Any other entries of
- 12 appearance for Cases 22663, 664, -665.
- MS. MUNDS-DRY: Yes, Mr. Hearing Examiner.
- Ocean Munds-Dry appearing for COG Operating, LLC, Concho
- 15 Oil & Gas, and Mongoose Minerals -- one you don't hear
- 16 very often so I want to make sure I list that one, as
- 17 well.
- 18 We entered our appearances earlier this
- 19 week, I believe.
- 20 EXAMINER BRANCARD: That was Mongoose?
- MS. MUNDS-DRY: Yes, Mongoose. Thank you.
- 22 And we have no objection to the case
- 23 proceeding by affidavit.
- 24 EXAMINER BRANCARD: All right. Any other entries
- 25 of appearance for Cases 22663, -664, -665.

- 1 (Note: No response.)
- 2 Ms. Shaheen, I believe Tap Rock has
- 3 objected, however, so where are we? Is Tap Rock going to
- 4 be filing competing cases?
- 5 MS. SHAHEEN: Tap Rock has filed a competing
- 6 case; however, the parties are negotiating and I
- 7 understand that they have agreed to request a continuance
- 8 to the next available docket. Tap Rock is hopeful that we
- 9 will get this resolved and Matador can move forward by
- 10 affidavit at that time.
- 11 EXAMINER BRANCARD: Mr. Bruce.
- 12 MR. BRUCE: Yeah, Mr. Examiner. I'm here to
- 13 play Let's Make a Deal with you today. I will trade two
- 14 dismissals for a continuance. The parties are in
- 15 negotiations and they have been making progress, but as
- 16 part of the process between Matador and Tap Rock Matador
- 17 has agreed to dismiss the first two cases, which are Bone
- 18 Spring cases, but they would like a short continuance, as
- 19 short as possible, on the third case, 22665, which
- 20 involves the Wolfcamp Formation.
- 21 EXAMINER BRANCARD: Okay. We are continuing
- 22 this to a hearing, is that correct, from a status
- 23 conference?
- 24 MR. BRUCE: The parties are trading -- at this
- 25 point are trading comments on an agreement by which Tap

1 Rock would participate in Matador's well, and if that's

- 2 the case it would be solely by affidavit.
- 3 EXAMINER BRANCARD: Okay. And so, Ms. Shaheen,
- 4 that means Tap Rock will not be going forward with its
- 5 case if all things work out?
- 6 MS. SHAHEEN: That's correct. Tap Rock will
- 7 dismiss its case once the parties have reached agreement.
- 8 EXAMINER BRANCARD: All right.
- 9 MR. BRUCE: Currently they are within a week or
- 10 10 days of doing so, Mr. Examiner.
- 11 EXAMINER BRANCARD. Okay. Are we thinking May
- 12 or June?
- 13 MR. BRUCE: I would prefer as early in May as
- 14 possible. Matador actually you asked me to ask for April
- 15 21, but that's kind of a problematic docket, shall we say.
- 16 EXAMINER BRANCARD: Yeah, we have 156 cases on
- 17 the docket right now.
- 18 MR. BRUCE: And only about six or seven fights.
- 19 Remember that, Mr. Examiner.
- 20 EXAMINER BRANCARD: Yeah, there are a bunch of
- 21 competing cases in there, too.
- Okay. Why don't we schedule these cases
- 23 for May 5 -- and I'll say "these cases" because, Mr.
- 24 Bruce, you're free to dismiss any of these cases. And so
- 25 these cases, 22663, 22664, 22665 will be continued to

- 1 May 5th for a hearing.
- 2 Since I'm sensing this is not contested I'm
- 3 not going to issue a Scheduling Order and, Mr. Bruce, you
- 4 can either continue the cases or dismiss them.
- 5 MR. BRUCE: Yes. I will be filing a continuance
- 6 today on the one case and dismissals on the other two.
- 7 EXAMINER BRANCARD: Okay. Any further comments,
- 8 then, on Cases 22663, -664, -665?
- 9 Are you okay. Ms. Shaheen?
- 10 MS. SHAHEEN: Yes, I am. Thank you, Mr.
- 11 Examiner.
- MR. BRUCE: Thank you.
- 13 EXAMINER BRANCARD: All right. So those cases
- 14 22663, 22664, 22665 will be set for the May 5th docket, if
- 15 they get continued; and if not, if they get dismissed,
- 16 bye-bye.
