- 2 EXAMINER BRANCARD: All right. Let's do the last
- 3 two cases before a break, then. So Items 50, 51, these are
- 4 Cases 22736, 22737, Spur Energy Partners.
- 5 MS. HARDY: Dana Hardy, with the Santa Fe office
- 6 of Hinkle Shanor, on behalf of Spur Energy Partners.
- 7 EXAMINER BRANCARD: Thank you. Are there any
- 8 other interested persons in Cases 22736, 22737?
- 9 Hearing none, Ms. Hardy, you may proceed.
- 10 MS. HARDY: Thank you. In Case Number 22736, Spur
- 11 seeks an order pooling additional interest owners under the
- 12 terms of Order Number R-22049, which pooled uncommitted
- 13 interest from a depth of approximately 4,000 feet to the
- 14 base of the Yeso formation in a 160-acre standard horizontal
- 15 spacing unit comprised of the S/2 of the S/2 of Section 27,
- 16 Township 17 South, Range 28 East, in Eddy County. That
- 17 order dedicated the unit to the Halberd 27 State Com 72H and
- 18 90H wells.
- 19 In Case Number 22737, Spur seeks an order pooling
- 20 additional interest owners under the terms of Order Number
- 21 R-22060. That order pooled uncommitted interest from a
- 22 depth of approximately 4,000 feet to the base of the Yeso in
- 23 a 320-acre standard horizontal spacing unit comprised of the
- N/2 of the S/2 and the S/2 of the N/2 of Section 27,
- 25 Township 17 South, Range 28 East. That order dedicated the

- 1 unit to the Halberd 27 State Com 50H, 51H and 71H wells.
- 2 Our exhibits in each case include the affidavit of
- 3 landman Blair Brummell. Exhibit A3 to Mr. Brummell's
- 4 affidavit is a plat of the tracts and the ownership
- 5 interest. The additional parties being pooled are
- 6 highlighted in yellow. And Exhibit A5 to Mr. Brummell's
- 7 affidavit is his chronology of contacts that discusses his
- 8 communications with the parties. Exhibit B is my notice
- 9 affidavit and includes the hearing notice letter, a chart
- 10 summarizing the mailing information, the certified mail
- 11 receipts, and the affidavits of publication.
- With that, unless there are questions, I request that
- 13 the exhibits be admitted into the record and that the cases
- 14 be taken under advisement. Thank you.
- 15 EXAMINER BRANCARD: Thank you.
- 16 Mr. McClure, any questions?
- 17 TECHNICAL EXAMINER McCLURE: No, sir, I don't
- 18 think I have any questions on either of these amendments.
- 19 EXAMINER BRANCARD: So, Ms. Hardy, looking at your
- 20 Exhibit A3, so is Occidental the only interest owner being
- 21 added here?
- MS. HARDY: So that is correct in Case
- 23 Number 22736, and then in Case Number 22737, there are a
- 24 couple. There -- it is Occidental, Permian Limited
- 25 Partnership, Kerr-McGee, and then one overriding royalty

- 1 interest, which is The Wright Company.
- 2 EXAMINER BRANCARD: Okay. So I guess you can -- I
- 3 don't know if you know the answer, but these are not small
- 4 interests that you're adding here. These are fairly
- 5 significant interests that both Occidental and Kerr-McGee
- 6 have. I didn't know Kerr-McGee still existed, but how --
- 7 were they missed? Or what happened in the first round?
- 8 MS. HARDY: You know, Mr. Examiner, what happened
- 9 the first round was that a different Oxy entity was named,
- 10 so it ended up that a different entity owned this interest,
- 11 but it took Oxy time also to figure out which of its
- 12 entities owned the interest. So we went back to re-pool the
- 13 additional Oxy entity. And Kerr-McGee is also an affiliate
- of Oxy, so it was just a matter of which Oxy entity owned
- 15 the interest, and we went back to pool them to clarify that
- 16 they were pooled.
- 17 EXAMINER BRANCARD: Okay. All right. Because
- 18 I -- yes, I see that there's an Oxy USA that must have been
- 19 previously pooled here.
- MS. HARDY: That's correct.
- 21 EXAMINER BRANCARD: Okay. Well, get your land
- 22 people, find all these things out the first time.
- 23 MS. HARDY: They do their best, Mr. Examiner.
- 24 EXAMINER BRANCARD: All right. Are there any
- other -- Mr. McClure, anything else?
