22 HEARING EXAMINER BRANCARD: Heard as in setting a
23 hearing date? Is that what I'm hearing you saying, Mr.
24 Bruce?

25 MR. BRUCE: Yes.

1 HEARING EXAMINER BRANCARD: So we can do a status
2 conference in July or a hearing in August. What's your
3 preference, Mr. Bruce?

4 MR. BRUCE: Hearing in August.

5 HEARING EXAMINER BRANCARD: Okay. Mr. Parrot,
6 any objections?

7 MR. PARROT: No objection, thank you.

8 HEARING EXAMINER BRANCARD: So we will set this
9 for August 4. We will issue a prehearing order in Cases
10 22605, 606, 607, 608.
