- 2 Items 41 and, I believe, 42. Cases 22689, 22690, Colgate
- 3 Operating.
- 4 MS. HARDY: Dana Hardy with the Santa Fe office
- of Hinkle Shanor on behalf of Colgate Operating.
- 6 HEARING EXAMINER BRANCARD: Ms. Hardy, do you
- 7 want these two cases to be considered together?
- MS. HARDY: Yes, please, Mr. Examiner.
- 9 HEARING EXAMINER BRANCARD: Are there any other
- interested persons for Case 22689, 22690?
- 11 (No audible response.)
- 12 HEARING EXAMINER BRANCARD: Hearing none, please
- 13 proceed.
- MS. HARDY: Thank you. In Case Number 22689,
- 15 Colgate seeks an order pooling uncommitted interest in the
- 16 Bone Spring Formation from the top of the formation at a
- depth of approximately 4320 feet, to a depth of
- 18 approximately 7673 feet, underlying a 160 acre standard
- 19 horizontal spacing unit comprised of the N/2 of the N/2 of
- 20 Section 35, Township 19 South, Range 28 East in Eddy County.
- 21 That unit will be dedicated to the Uluru 35 Fed State Com
- 22 121H well.
- In Case Number 22690, Colgate seeks an order
- 24 pooling uncommitted interest in the Bone Spring Formation,
- 25 again from the top of the formation at a depth of

- 1 approximately 4320 feet to a depth of approximately 7673
- 2 feet, underlying a 160 acre standard horizontal spacing
- 3 unit, comprised of the S/2 of the N/2 of Section 35,
- 4 Township 19 South, Range 28 East in Eddy County. That unit
- 5 will be dedicated to Uluru 35 Fed State Com 122H well.
- 6 And in both of these cases, the depth severance
- 7 is to address development in the adjacent acreage, and we
- 8 are pooling the First Bone Spring Formation in both of these
- 9 cases.
- 10 Our exhibit packet includes the checklist, the
- 11 affidavit and attachments of landman Mark Hajdik, the
- 12 affidavit and attachment of geologist David DaGian and the
- 13 notice affidavit.
- Mr. Hajdik provides the C-102, the plat, the well
- 15 proposal and AFEs and a chronology of contacts of the
- 16 parties. The tract ownership information and the pooled
- 17 parties are included in Exhibit A-3.
- 18 Mr. DaGian's exhibits for each case include the
- 19 standard geology exhibits, a location map, cross section
- 20 map, structure map, structural and stratigraphic cross
- 21 section and a gun barrel.
- 22 With the notice affidavit, we provided a hearing
- 23 notice letter, a chart listing the parties who were
- 24 notified, the certificate mail receipts, and the affidavit
- of publication. And as was true in the prior case, we

- 1 published notice, I think, three times to get additional
- 2 interest owners who were identified. And we also, again,
- 3 sent notices to multiple addresses to some of the parties
- 4 who were unlocatable.
- 5 And because these cases involve depth severances,
- 6 we notified the parties of interest in the Bone Spring above
- 7 and below the depth severance.
- 8 With that, unless there are questions, I request
- 9 that the exhibits be admitted and these cases be taken under
- 10 advisement.
- 11 HEARING EXAMINER BRANCARD: Thank you. Mr. Lowe,
- 12 questions?
- 13 TECHNICAL EXAMINER LOWE: I have one question for
- 14 you Dana Hardy. To get clarification of your exhibit, what
- 15 it says, what it's saying, on Page 20 of 151, it has your
- 16 listing of the working interest owners who are -- where
- 17 everything is highlighted in yellow, and there is a
- 18 character here, John G. Brokovich. In the right column it
- 19 says operator and they all say yes except for him. What
- 20 does that mean?
- MS. HARDY: Oh, you know, actually, Mr. Lowe, I
- 22 think that column is to indicate who is being force pooled.
- 23 The operator reference at the top just refers to Colgate
- 24 which is on the left in that chart. So Colgate is the
- 25 operator, and then the other parties are being force pooled.

Page 6 They are highlighted. TECHNICAL EXAMINER LOWE: So all the yellow are 2. 3 being force pooled and the white one is not. MS. HARDY: That's correct. 5 TECHNICAL EXAMINER LOWE: So being Mr. Brokovich 6 is participating then? 7 MS. HARDY: I believe so. 8 TECHNICAL EXAMINER LOWE: I just want to get an 9 understanding of that. 10 MS. HARDY: Sure. 11 TECHNICAL EXAMINER LOWE: Thank you. 12 MS.
