- 3 MS. HARDY: Dana Hardy with Hinkle Shanor
- 4 on behalf of Spur Energy Partners.
- 5 HEARING OFFICER BRANCARD: Are there any
- 6 other parties for Case 22738?
- Hearing none, Ms. Hardy, you may proceed.
- 8 MS. HARDY: Thank you.
- 9 Spur seeks an order pooling additional
- 10 interest owners under the terms of Order
- 11 Number R-22602, which pooled uncommitted interest
- 12 from the top of the Yeso formation to a depth of
- 13 approximately 4,000 feet in a 160-acre standard
- 14 horizontal spacing unit comprised of the north half
- of the south half of Section 27, Township 17 South,
- 16 Range 28 East in Eddy County.
- 17 That order dedicated the unit to Halbred
- 18 27 State Com 21H well and designated Spur as
- 19 operator of the unit and the well.
- 20 Since the order was entered, Spur
- 21 identified additional interest owners that should be
- 22 pooled under the terms of the order.
- 23 We have provided the affidavit of landman
- 24 Blair Brummell with our exhibits.
- The tract ownership information and pooled

- 1 parties are identified in Exhibit A3.
- 2 We are pooling two additional parties, one
- 3 working interest owner, which is Kerr-McGee and one
- 4 override which is the Wright Company.
- 5 Exhibit B is my notice affidavit and we've
- 6 included a chart the shows the mailing dates and
- 7 included the certified receipts. We did not receive
- 8 a return for Kerr-McGee but the Postal Service
- 9 tracking shows that they did pick up the envelope.
- We also timely published and we actually
- 11 published twice because we were adding parties.
- 12 So with that, unless there are questions,
- 13 I request the exhibits be admitted and the case be
- 14 taken under advisement.
- 15 HEARING OFFICER BRANCARD: Thank you.
- 16 Mr. Garcia?
- 17 TECHNICAL HEARING OFFICER GARCIA: Are you

- 7 covered everyone, we filed this application to
- 8 specifically include Kerr-McGee.
- 9 HEARING OFFICER BRANCARD: Thank you.
- I was wondering where Kerr-McGee was these
- 11 days.
- 12 As your notice to Kerr-McGee, I thought it
- 13 was interesting that your folks sent the AFE to two
- 14 Kerr-McGee addresses but you only sent the notice to
- one Kerr-McGee address, maybe why you had a little
- 16 problem getting it picked up there.
- 17 MS. HARDY: You know, they did pick it up,
- 18 actually a month ago, according to the Postal
- 19 Service tracking, but we just didn't receive a green
- 20 card. I don't know why.
- 21 HEARING OFFICER BRANCARD: Okay.
- 22 Mr. Garcia, I'm sure I missed your
- 23 question.
- 24 TECHNICAL HEARING OFFICER GARCIA: You did
- 25 not. I was curious about how you missed 25 percent
